RESOLUTION AWARDING CONTRACT FOR THE PURCHASE OF  
TWO (2) 2016 TORO WORKMAN HDX AUTO TRANSMISSION UTILITY VEHICLES EACH  
WITH ONE (1) CONTRACT OPTION  
CONTRACT NO. PCC-9018-16**

**WHEREAS**, the Director of Finance and Administration Services and CFO of Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part hereof, and such funds are provided for in the Capital Budget \$46,488.06 (34-215-15-045-674-005); and

**WHEREAS**, the Somerset County Purchasing Department did on January 4, 2016 advertise in the Courier News on the Park Commission website [www.somersetcountyparks.org](http://www.somersetcountyparks.org) and on Somerset County website [www.co.somerset.nj.us](http://www.co.somerset.nj.us); and

**WHEREAS**, one (1) sealed bid was received, opened, and read in public on January 20, 2016 at 2:30 PM prevailing time for two (2) 2016 Toro Workman HDX Auto Transmission Utility Vehicles, each with one (1) contract option, Contract No. PCC-9018-16 and the cost is not to exceed \$46,488.06; and

**WHEREAS**, the bid was reviewed by the Fleet Manager and it was determined that the proposal submitted by Storr Tractor Company, 3191 Highway 22, Branchburg, NJ 08876 meets the requirements of the Park Commission specifications; and

**WHEREAS**, the Environmental Science Manager wishes to purchase one (1) 2016 Toro HDX Auto Transmission Utility Vehicle, and the Horticulture Manager wishes to purchase one (1) 2016 Toro HDX Auto Transmission Utility Vehicle, each one with one (1) contract option from an authorized vendor under Contract No. PCC-018-16.


**NOW, THEREFORE, LET IT BE RESOLVED** by the Somerset County Park Commission that the bid be accepted for the following:
