WHEREAS, as an appropriation will be included in the 2016 adopted budget of which 26.25% of the appropriation will be made available in the adopted 2016 temporary budget, Chief Financial Officer certification will take place at that time in the form of a purchase order, line item Nutrition Project for the Elderly (01-201-27-012-686-000); and

WHEREAS, sealed proposals were received, opened and read in public on Tuesday, October 22, 2014 at 2:30 P.M. prevailing time for Senior Nutrition Meals, Contract #CC-0114-16; and

WHEREAS, one (1) bidder submitted a proposal; and

WHEREAS, the bid was reviewed by the Project Director and it was determined that the bid as submitted by Whitsons Food Service Corporation, 1800 Motor Parkway, Islandia, NY 11749 meets the necessary requirements of the County specifications; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Chosen Freeholders of the County of Somerset that the bid as submitted by Whitsons Food Service Corporation be and is hereby accepted for the first year of a three year contract:
