WHEREAS, the Chief Financial Officer of Somerset County has certified in writing the availability of funds for the purposes set forth in this Resolution, such certification on file with the Deputy Clerk of the Board, and such funds are provided for in the duly adopted budget of the County of Somerset, line items (02-213-14-647-454-940) \$271,959.00, (02-213-13-647-454-940) \$450,000.00 AND (04-215-140-90-454-806) \$45,905.08; and

WHEREAS, sealed proposals were received, opened and read in public on Thursday, October 2, 2014 at 3:30 prevailing time for Local Safety Project for Promenade Boulevard, County Route No. 685, including East Main Street Sidewalks, Bridgewater Township, Somerset County, New Jersey, Contract No. 14012; and

WHEREAS, three (3) bidders submitted proposals; and

WHEREAS, the bids were reviewed by the County Engineer and it was determined that the bid as submitted by Top Line Construction Corporation, 22 Fifth Street, Somerville, NJ 08876 meets the requirements of the County specifications.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Somerset that the bid as submitted by Top Line Construction Corporation be and is hereby accepted based on the lowest total cost for:
