WHEREAS, the Chief Financial Officer of Somerset County has certified in writing the availability of funds for the purposes set forth in this Resolution, such certification on file with the Deputy Clerk of the Board, and such funds are provided for in the duly adopted budget of the County of Somerset, line item (04-215-131-50-454-809) \$65,680.00; and

WHEREAS, one (1) sealed proposal was received, opened and read in public on Thursday, January 5, 2017 at 2:00 P.M. for Guide Rail and Guide Rail Parts, Open Ended Contract #CC-0039-17, Co-operative Pricing Bid #2-SOCCP; and

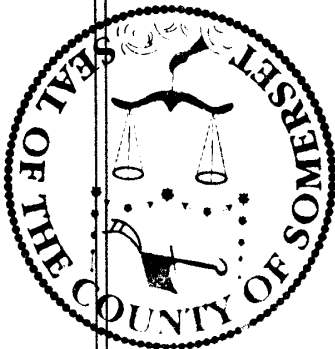
WHEREAS, the bid was reviewed by the Road and Bridge Supervisor and it was determined that the bid as submitted by Chemung Supply Corporation, PO Box 527, Elmira, NY 14902, meet the requirements of the County specifications for items 1-54, 61-95, 112-126 and 139-173; and

WHEREAS, no bids were received for items 55-60, 96-112 and 124-138, and it is recommended quotes to be obtained as needed; and

WHEREAS, prices will remain firm for the first six (6) months of the contract period, and each subsequent six (6) months the awarded vendors may file for a price change consistent with and relative to price changes originating with the manufacturer, which will remain for the next six (6) month period if agreed upon by the Supervisor of the Somerset County Road and Bridge Division.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Somerset that the bid as submitted by Chemung Supply Corporation, is hereby accepted for the items as listed on Schedule of Prices on file in the Office of the Deputy Clerk of the Board; and

BE IT FURTHER RESOLVED by the Board of Chosen Freeholders of the County of Somerset that the Director and Deputy Clerk of the Board are hereby authorized to execute the proper contracts and the Purchasing Agent is hereby authorized to issue Purchase Orders as needed per bid proposal and specifications approved as to form by County Counsel.
