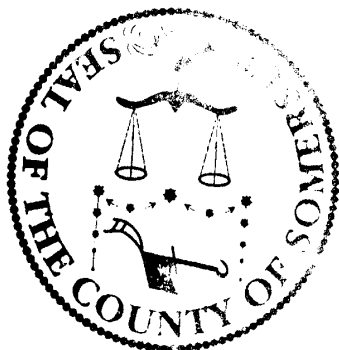
WHEREAS, only one (1) bidder submitted a proposal; and
