

AUTHORIZING AWARD OF CONTRACT FOR SENIOR SERVICES UNDER AGING 2019-2021 AREA PLAN CONTRACT (DOAS19AAA015) CONTRACT # CY-COM-0009-18R REBID FOR THE FOLLOWING AREAS: CERTIFIED HOME HEALTH AIDES HOUSEKEEPING/CHORE SERVICES/SENIOR GROCERY SHOPPING FIRST OF THREE YEAR CONTRACT

WHEREAS, the County of Somerset properly advertised seeking requests for Senior Services Under Aging Area Plan 2019-2021 (DOAS18AAA015) Contract #CY-COM-0009-18R in accordance with N.J.S.A. 40A:11-4.1 et seq.; and

WHEREAS, the Chief Financial Officer of Somerset County has certified in writing the availability of funds for the purposes set forth in this Resolution, such certification on file with the Deputy Clerk of the Board, and such funds are provided for in the duly adopted budget of the County of Somerset, line item (02-213-19-681-280) \$31,138.00, (02-213-19-366-681-280) \$25,253.00 and the adopted temporary budget of the County of Somerset, Line item (01-201-27-012-681-280) \$7,981.00; and

WHEREAS, the County of Somerset Purchasing Department did advertise for awarding County, SSBG, and Older American Act funds in the Courier News, Star Ledger, and via a posting on the County website, www.co.somerset.nj.us, on February 1, 2019; and

WHEREAS, five (5) sealed proposals were received, opened and read for Senior Services Under Aging Area Plan 2019-2021 (DOAS19AAA015) Contract #CY-COM-0009-18, in accordance with N.J.S.A. 40A:11-4.1 et seq. in public on February 21, 2019 at 2:30 p.m. prevailing time; and

WHEREAS, the County of Somerset Office of Aging is recommending that the County enter, with the following organizations to implement these services for the first year of the contract:

WHEREAS, all contracts are renewable annually (up to a three-year period under the 2019-2021 Area Plan Contract process) contingent upon contract compliance and funding availability; and

WHEREAS, the County reserves the right to extend contracts an additional two (2) one-year terms.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Somerset as follows:

1. The 2019-2021 Area Plan Contract submitted to the Board of Chosen Freeholders and on file with the Deputy Clerk of the Board be and is hereby approved with various subcontractors as listed above and any other subcontractors in accordance with the County 2019-2021 Area Plan Contract contingent upon the County receiving formal notification from the New Jersey Department of Human Services; and
2. That the engagement of the above named subcontractors has been in conformance with a Competitive Contract process, Local Public Contract Law, N.J.S.A. 40A:11-4.1 et seq.

BE IT FURTHER RESOLVED a notice of this award shall be published in the Courier News as required by law within twenty (20) days of its passage.
