

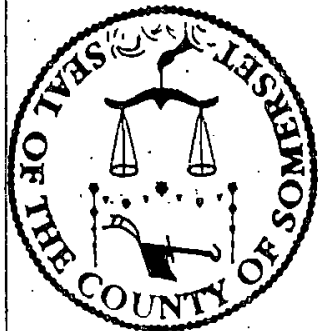
REJECTING THE RFP RESPONSE FOR MARKETING OF UNPROCESSED

OPTION A: UNPROCESSED FIBER MATERIALS: #56 SORTED RECYCLED PAPER
AND #11 OLD CORRUGATED CARDBOARD WITH CHIPBOARD INCLUSIONS
OPTION B: UNPROCESSED COMMINGLED RECYCLED MATERIALS – GLASS
BOTTLES AND JARS (ALL COLORS), STEEL, BI-METAL AND ALUMINUM CANS,
AND PLASTIC BOTTLES/CONTAINERS #1 - #7

WHEREAS, one (1) sealed proposal was received, open and read in public on Thursday, December 5, 2019 at 2:30 P.M Marketing of Unprocessed Recyclable Materials, Contract #: RC-XS-0002-20: Option A: Unprocessed Fiber Materials: #56 Sorted Recycled Paper and #11 Old Corrugated Cardboard with Chipboard Inclusions; Option B: Unprocessed Commingled Recycled Materials – Glass Bottles and Jars (all colors), Steel, Bi-Metal and Aluminum Cans, and Plastic Bottles/Containers #1 - #7; and

WHEREAS, it is the recommendation of the Recycling Superintendent that the RFP response be rejected in accordance with N.J.S.A. 40A:11-13.2(d), the specifications shall be revised and the contract re-solicited; and

WHEREAS, prior to the re-release of the revised RFP, services are required for the afore mentioned services, spot marketing quotes shall be obtained for the months of January and February 2020.
