

**AWARD OF CONTRACT FOR SITE-WIDE LABORATORY TESTING SERVICES

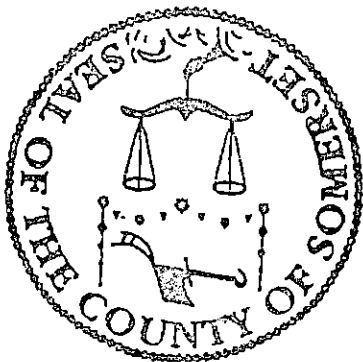


