

**SOMERSET COUNTY PARK COMMISSION  
RESOLUTION AWARDING THE  
ONE (1) ONE-YEAR OPTION TO EXTEND  
FOR ARMORED CAR SERVICES  
CONTRACT NO. PCC-0034-23**

**WHEREAS**, the Treasurer of the Somerset County Park Commission has certified in writing the availability of funds for the purposes set forth in this resolution, such certification being attached hereto and made part of hereof, and such funds are provided for in the temporary budget of the Somerset County Park Commission: \$10,521.75 (31-201-20-850-103-290); and

**WHEREAS**, the Somerset County Purchasing Office did on July 6, 2023 advertise on the Park Commission website [www.somersetcountyparks.org](http://www.somersetcountyparks.org), and on the Somerset County website [www.co.somerset.nj.us](http://www.co.somerset.nj.us) for bids for Armored Car Services; and

**WHEREAS**, one (1) sealed bid(s) was/were received, opened, and read in public on July 25, 2023 at 3:30 pm prevailing time for Armored Car Service, Contract No. PCC-0034-23; and

**WHEREAS**, the bid(s) was/were reviewed and it was determined that the bid(s) as submitted by Eastern Armored Services, Inc., PO Box 8733, Trenton, NJ 08650 meet(s) the requirements of the Park Commission specifications; and

**WHEREAS**, Eastern Armored Services, Inc.(hereinafter, the "Vendor") was awarded the first year of the Contract, by Park Commission resolution RR24-08-166 on August 17, 2023; and

**WHEREAS**, the services of the Vendor have met the requirements of the specification in an efficient and quality manner during the previous year(s) of the Contract, thus, it is therefore recommended that the optional one-year extension of the Contract be awarded to the Vendor for:
