9.11.2 PROFILE

9.11.2.1 Population

The population of Hillsborough is estimated to be 38,303, based on information gathered during the 2010 U.S. Census. Census population estimates as of July 2017 indicated a total population of 40,003.

9.11.2.2 Location

Hillsborough is in the southern portion of Somerset County. Hillsborough is 54 square miles, the largest jurisdiction in Somerset County. Route 206 is the main State highway running north/south through the Township. County Route 514 (Amwell Road) runs east/west through the Township. Hillsborough is bordered by Hunterdon County to the west; Branchburg, Raritan, and Somerville to the north; Manville, Franklin, and Millstone to the east; and Montgomery to the south.

9.11.2.3 Brief History

Hillsborough assumed its own identity in 1771 when it became a Township. Hillsborough and surrounding areas were first explored by the Dutch in the middle of the 17th Century. Hillsborough Road got its name from early landowners. Some believe that Hillsborough was named for Lord Hillsborough.

9.11.2.4 Governing Body Format

Hillsborough's governing body is in the form of a township committee, which consists of the mayor, deputy mayor, and three committeepersons. The Township also contains the following departments: administration/clerk, building, engineering, fire safety, health, municipal court, office of emergency management, parks and recreation, planning, police, public works, social services, tax and finance, tax assessment, and zoning.

9.11.2.5 Growth/Development Trends

Hillsborough did not note any major residential or commercial development, or major infrastructure development planned for the next 5 years in the municipality (updated in 2018).

The classifications listed above relate to Hillsborough's ability to provide effective services to lessen its vulnerability to the natural hazards identified. These classifications can be viewed as a gauge of the community's capabilities in all phases of emergency management (preparedness, response, recovery and mitigation) and are used as an underwriting parameter for determining the costs of various forms of insurance. The CRS Class applies to flood insurance, while the BCEGS and Public Protection classifications apply to standard property insurance. CRS classifications range on a scale of 1 to 10 with Class 1 being the best possible classification, and Class 10 representing no classification benefit. Firewise classifications include a higher classification when the subject property is located beyond 1,000 feet of a creditable fire hydrant and is within 5 road miles of a recognized fire station.

9.11.6.2 Hazard Vulnerabilities Identified

The Township has identified the Green Hills Development off of Dukes Parkway East to be an area of concern.

It is estimated that in Hillsborough, 195 residents live within the 1% annual chance flood area (NFIP Special Flood Hazard Area). \$1,946,578,000 (25.3%) of the municipality's general building stock replacement cost value (structure and contents) is located within the 1% annual chance flood area.

There are 185 NFIP policies in the community and there are 53 policies located within the 1% annual chance flood area. FEMA has identified 21 Repetitive Loss (RL) properties including 3 Severe Repetitive Loss (SRL) properties in the municipality.

HAZUS-MH estimates that for a 1% annual chance flood, \$42,500,000 (0.55%) of the municipality's general building stock replacement cost value (structure and contents) will be damaged, 1,082 households may be displaced, 615 people may seek short-term sheltering, and an estimated 1,304 tons of debris could be generated.

9.11.8.1 Explanation of Priorities

Explanations of priority classifications used to assess the mitigation initiatives described in this annex are presented below:

High Priority = A project that meets multiple objectives (i.e., multiple hazards), where potential benefits exceed the costs. High-priority projects have funding secured or are on-going projects that meet eligibility requirements for the Hazard Mitigation Grant Program (HMGP) or Pre-Disaster Mitigation (PDM) Grant Program. High-priority projects can be completed in the short term (1 to 5 years).

Medium Priority = A project that meets goals and objectives, where the potential benefits outweigh the costs. Funding for medium-priority projects has not been secured but these projects are eligible for grants under HMGP, PDM, or other grant programs. These projects can be completed in the short term, once funding is completed. Medium-priority projects will become high-priority projects once funding is secured.

Low Priority = A project that will mitigate the risk of a hazard, where the potential benefits do not exceed the costs or have benefits that are difficult to quantify. Funding for low-priority projects has not been secured and these projects are not eligible for HMGP or PDM grant funding. The timeline for completion is considered long term (1 to 10 years). Low-priority projects may be eligible other sources of grant funding from other programs. A low-priority project could become a high-priority project once funding is secured as long as it could be completed in the short term.


