Re: Participation in Somerset County Multi-Jurisdictional Hazard Mitigation Plan - Five Year Update

Dear Mr./Ms. Last Name,

Somerset County has recently received grant funding from the Federal Emergency Management Agency (FEMA) to prepare the second update of our Multi-Jurisdictional Hazard Mitigation Plan (HMP). Updates are mandatory on a five-year cycle following FEMA approval in order to comply with the Disaster Mitigation Act of 2000 (DMA 2000) and maintain eligibility for certain types of federal disaster mitigation project funding (such as the Hazard Mitigation Grant Program and the Pre-Disaster Mitigation Program). As in the past, in order to maintain compliance with the DMA 2000, a community must either: prepare its own HMP, or participate in a "multi-jurisdictional" HMP development process.

Somerset County has again elected to use its grant funding to update the countywide Multi-jurisdictional HMP, including updates of the associated municipal-specific HMP components (annexes) for all 21 of our municipalities. The plan update process will be jointly managed by the Office of Emergency Management and the Planning Division. We are writing to you today to thank you for your prior participation and to encourage your ongoing involvement in this important endeavor as we continue to work toward becoming a more sustainable and disaster-resistant county. Continued participation by your municipality will provide the following advantages:

- Participating jurisdictions will maintain compliance with DMA 2000 and remain eligible for potential future FEMA funding, once FEMA approves the final updated plan and it is formally adopted by the jurisdiction's local governing body. Non-participating municipalities will not be eligible for FEMA mitigation funding.
- Local involvement in the multi-jurisdictional planning committee provides a forum for working collaboratively to identify planning and implementation strategies, resources and partnerships; and for sharing technical, public outreach and financial solutions that can reduce hazard risks, effects and costs.
- Multi-jurisdictional HMPs provide a framework for addressing broader, regional issues that are best dealt with on a larger scale.
- Multi-jurisdictional planning creates economies of scale; enables the pooling of limited resources to maximize investments; and effectuates a comprehensive, holistic approach to helping communities; the economy and the environment recover in the event a disaster occurs.
- Participation can enable municipalities to earn credits toward Sustainable Jersey's Emergency Management and Resiliency Actions.

While natural disasters cannot be prevented from occurring, continued implementation of the Multi-Jurisdictional Hazard Mitigation Plan for the County of Somerset over the long-term will gradually, but steadily, lessen the impacts associated with hazard events in our county and make our communities more resilient.

In addition, please consider establishing a Municipal Hazard Mitigation Committee, that is chaired by your primary MHMR Representative, and that includes an elected official and/or municipal administrator; individuals who participated in the last HMP update or in the initial HMP development process; representatives from your emergency management office, planning department, engineering department, public works department, etc. who are familiar with the hazards in your community and can assist with integrating hazard mitigation into the municipal operations, programs and functional plans. Please remember that direct, specific involvement by your municipality is required in order for FEMA to ultimately approve your updated municipal HMP plan component of the Multi-jurisdictional Plan for Somerset County.

MHMRs and other HMP Committee members from all participating jurisdictions are encouraged to attend a Kickoff Meeting for the project on September 28, 2017 at 6:00 PM in Classrooms D & E at the Somerset County Emergency Services Training Academy, 402 Roycefield Road, Hillsborough.

A RESOLUTION ADVISING THE SOMERSET COUNTY BOARD OF CHOSEN FREEHOLDERS OF MUNICIPAL PARTICIPATION IN THE SECOND UPDATE OF THE SOMERSET COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN

WHEREAS, the current Somerset County All-Hazards Mitigation Plan approved by the Federal Emergency Management Agency (FEMA) includes a Jurisdictional Annex for [NAME OF MUNICIPALITY, BOROUGH/TOWNSHIP], through which the municipality is eligible for potential pre- and post-hazard mitigation planning and mitigation funding; and
