# **SECTION 3: PLANNING PROCESS**

## INTRODUCTION

This section includes a description of the planning process used to develop the Somerset County Hazard Mitigation Plan, including how it was prepared, who was involved in the process, and how the public was involved.

To ensure that the Plan met the requirements of the DMA 2000, an approach to the planning process and plan documentation was developed to achieve the following two goals:

1. The Plan will be multi-jurisdictional and consider natural hazards facing Somerset County, thereby satisfying the natural hazards mitigation planning requirements specified in DMA 2000. The Project Management Team (PMT) led by the County Planning Division and Office of Emergency Management, invited all municipalities in the county to join with them in the preparation of a Somerset County Multi-Jurisdictional All-Hazard Mitigation Plan, in addition to the North Plainfield Board of Education, and the Somerset Raritan Valley Sewerage Authority. Somerset County and all of its municipalities are participating in the Plan as indicated in Table 3-1 below, and are represented on the Mitigation Planning Committee (MPC).

This Somerset County Multi-Jurisdictional Hazard Mitigation Plan (HMP) update was written using the best available information obtained from a wide variety of sources. Throughout Plan development, a concerted effort was made to gather information from municipal and regional agencies and staff as well as stakeholders, federal and state agencies, and the residents of the County. The MPC solicited information from local agencies and individuals with specific knowledge of certain natural hazards and past historical events, as well as considering planning and zoning codes, ordinances, and other recent planning decisions. The natural hazard mitigation strategies identified in this Plan have been developed and updated through an extensive planning process involving local, county and regional agencies, County residents and stakeholders.

2. The Plan was developed and updated following the process outlined by DMA 2000, FEMA regulations, and FEMA and NJOEM guidance. Following this process will ensure all the requirements are met and support Plan review.

This section of the Plan describes the mitigation planning process, including (1) Preparing to Plan; (2) Planning Partnership - Organization and Activity; (3) Stakeholder and Public Outreach and Involvement; (4) Coordination with Existing Mitigation Efforts and Programs; (5) Integration of Existing Data, Plans, and Information; and (5) Continued Public and Stakeholder Involvement.

# HAZARD MITIGATION IN SOMERSET COUNTY - PREPARING TO PLAN

Many parties supported preparation of this plan, including: the Project Management Team (PMT), Mitigation Planning Committee (MPC) Steering Committee and other stakeholders. This planning process does not represent the start of hazard risk management in the County; rather it is part of an ongoing process that various State, County and local agencies and individuals have continued to embrace.

- Various regional, county and local agencies and governments have been involved in natural hazard risk assessment, mitigation planning and project activities, prior to and/or unrelated to the current planning effort. Such activities provide a strong foundation for subsequent efforts, and an awareness and understanding of the need for and benefits of mitigation planning across a broad range of regional, county and local governments and stakeholders. Several examples of such activities are presented here.
- All jurisdictions in the County participate in the National Flood Insurance Program, and manage their floodplains according to the requirements of participation in that program.

# PLANNING PARTNERSHIP - ORGANIZATION AND ACTIVITY

This section of the Plan identifies how the planning process was organized with the many "planning partners" involved, and outlines the major activities that were conducted in the development of this Plan.

## **Organization of Planning Partnership**

Recognizing the need to manage natural risk within the County, and to meet the requirements of the DMA 2000, the Somerset County Board of Chosen Freeholders resolved to develop an update to the 2014 Somerset County Hazards Mitigation Plan.

This current plan update represents a collaborative effort led by the Somerset County Planning Division and the Somerset County Office of Emergency Management. On November 28, 2016 Somerset County was notified by NJOEM that their application for a planning grant to update the 2014 Multi-Hazard Mitigation Plan under FEMA's Pre-Disaster Mitigation Competitive Grant Program PDMC-PL-02-NJ-2015-005 was approved. The County selected a contract planning consultant (AECOM Technical Services, Inc. - Clifton, NJ) through a competitive process. A contract between AECOM Technical Services, Inc. (AECOM) and the County was executed on June 13, 2017 and notice to proceed was issued on July 7, 2017. Specifically, as the "contract consultant", AECOM was tasked with:

Working with the County's Hazard Mitigation Committee and their partners to update and identify mitigation initiatives for which the County and partners may implement to reduce risks and foster resiliency due to natural hazard events.

- Recommending actions to ensure County and participating partners are in good standing and demonstrate continued compliance with National Flood Insurance Program (NFIP) regulations, including local floodplain ordinances and permitting requirements
- Preparation of an updated, FEMA approved Hazard Mitigation Plan for the County and updated annexes for participating partners
- In support of these tasks, the consultant scope included:
  - Assisting with the development and implementation of a public and stakeholder outreach program
  - Data collection
  - Facilitation and attendance at meetings (Planning committee, stakeholder, public and other) 0
  - o Guidance regarding outreach to other various outside groups, facilities, and agencies for information vital to risk identification and mitigation strategies
  - Review of hazards of concern, and update of hazard profiling and risk assessment
  - Assistance with the development of updated mitigation planning goals and objectives
  - Assistance with the screening of new mitigation actions, identification of appropriate actions, and status updates of actions in the 2014 plan.
  - Assistance with the prioritization of mitigation actions
  - Authoring of the Draft and Final Plan documents
  - Provision of a hazard mitigation planner to lead the planning effort and support the County in the preparation of a FEMA-approved hazard mitigation plan

The County formed a MPC comprised of appropriate municipal personnel, local emergency first responders, and other stakeholders to effectively guide the overall process, provide significant input, and partner with AECOM to develop a FEMA-approved Plan. The MPC included representatives from the jurisdictional partners noted in Table 3-1, along with Steering Committee members comprised of representatives of county and regional agencies, organizations and utility authorities; together with the Project Management Team.

On July 19, 2017, Somerset County notified all 21 municipalities within the County of the pending planning process and invited them to formally participate in the plan's second update. Municipalities were provided with a copy of the Planning Partner Expectations document and asked to formally notify the county of their intent to participate (via executed Resolution to Participate) and to identify a planning point of contact to serve on the MPC and represent the interests of their respective community. The Planning Partners Expectations document outlines the responsibilities of jurisdictional representatives serving on the MPC, municipal hazard mitigation planning committees and associated steering Committee members. and posted the County **HMP** website: https://www.co.somerset.nj.us/home/showdocument?id=26168

As noted previously, the MPC was assembled to represent each of the municipalities participating in the Plan. It consists of all a municipal hazard mitigation officer (HMO) and alternate HMO from each of the twenty one (21) participating municipalities, the participating school district and utility authority and all members of the PMT and Steering Committee.

The Planning Committee was charged with the following:

- Represent their jurisdiction throughout the planning process;
- Establish Plan development goals;
- Establish a timeline for completion of the Plan;
- Ensure that the Plan meets the requirements of DMA 2000 and FEMA and NJOEM guidance;
- Solicit and encourage the participation of regional agencies, a range of stakeholders, and citizens in the Plan development process;

- Assist in gathering information for inclusion in the Plan, including the use of previously developed reports and data;
- Organize and oversee the public involvement process;
- Report on progress of 2014 HMP mitigation actions:
- Identify, develop and prioritize appropriate mitigation initiatives;
- Report on progress of 2014 HMP integration into other planning processes and municipal operations;
- Review, amend and approve all sections of the Plan;
- Develop and author the jurisdictional annex for their jurisdiction;
- Develop, revise, adopt, and maintain the Plan.

It is noted that the Resolution of Intent to Participate identifies the above "Planning Partner Expectations" as serving to identify those activities comprising overall participation by jurisdictions throughout the planning process. It is recognized that the jurisdictions in Somerset County have differing levels of capabilities and resources available to apply to the planning process, and further have differing exposure and vulnerability to the natural hazard risks being considered in this Plan. It was Somerset County's intent to encourage participation by all jurisdictions, and to accommodate their specific needs and limitations while still meeting the intents and purpose of Plan participation. Such accommodations have included the utilization of focus group sessions comprised of topic-specific subject matter experts to gain their perspectives on hazard risks, vulnerabilities and potential solutions; and engaging AECOM and County OEM staff to provide direct one-on-one assistance to municipal HMOs throughout the update process.

Ultimately, jurisdictional participation is evidenced by a completed annex (chapter) of the Plan wherein the jurisdiction has identified their planning points of contact, evaluated their risk to the hazards of concern, identified their capabilities to effect mitigation in their community, and identified and prioritized an appropriate suite of mitigation initiatives, actions, and projects to mitigate their natural hazard risk. All participating jurisdictions have been provided a sample plan adoption resolution, and are anticipated to adopt the plan upon its approval by the reviewing agencies (FEMA and NJOEM).

Table 3-2 shows the current municipal members of the MPC, at the time of this Plan's publication. Please note that while Steering Committee members are also part of the overall project MPC, the list below only identifies those MPC members representing participating jurisdictions. Steering Committee members are identified in Table 3-2.

To facilitate plan development, with support from their contract consultant, Somerset County developed a Steering Committee to provide guidance and direction to the planning effort, and to ensure the resulting document will be embraced both politically and by the constituency within the planning area.

The Steering Committee was charged with:

- Providing guidance and overseeing the planning process on behalf of the general planning partnership.
- Attending and participating in Steering Committee meetings.
- Assisting with the development and completion of certain planning elements, including:
  - o Identification of "Hazards of Concern"
  - Public and Stakeholder Outreach
  - Mitigation Planning Goals and Objectives
  - o Identification and screening of appropriate mitigation strategies and activities
  - Evaluation of the new Flood Resiliency Framework document, and the new Energy Resiliency Framework
- Reviewing and commenting on plan documents prior to submission to NJOEM and FEMA.

It is noted that prior to the general project Kick-Off meeting, the PMT, which is a subset of the MPC and Steering Committee was assembled to initiate the planning process and assist with overall project administration including the formation of the MPC and Steering Committee. Recognizing the need for, and significant benefit of, creating an equal partnership between the Emergency Management Office and Planning Division given the nature of this particular planning project, the PMT includes project co-leads from the County Planning Division and Emergency Management Office. The Project Management Team contacts for this 2019 plan update, and future mitigation planning activities, are as follows:

Approximately half of the members of the Steering Committee who participated in the development of the initial 2009 plan and 2014 plan update also participated in the current 2019 plan update. Steering Committee members were contacted by the PMT in the summer of 2017, at the outset of the plan update process. Past members were invited to continue their past participation. New agency/organization representatives were invited to fill vacancies resulting from the loss of prior members due to retirement and attrition. Members with a broad range of expertise were sought in order to provide valuable input and feedback from diverse perspectives and unique subject matter areas. As part of the 2019 plan update, Steering Committee members were invited to attend the project Kickoff Meeting on September 28, 2017, which was a joint meeting with the full HMP Committee; a separate meeting of Steering Committee only held on February 21, 2018; and the Mitigation Planning Roundtable on April 26, 2018, which was also a joint meeting with the larger MPC Committee. The Steering Committee reviewed the updated Risk Assessment Interim Deliverable; the updated Mitigation Strategy Mission, Goals, and Objectives; the new Flood Resiliency Framework and Energy Resiliency Framework documents; all of the draft updated HMP Sections and the county-level worksheets including, mitigation planning capabilities and integration, implementation status of past mitigation initiatives and updated mitigation strategy projects and initiatives for inclusion in the 2019 HMP update. Steering Committee members also participated in the Focus Group Meetings held in November 2017 and January 2018 as part of the plan update. Members provided unique insights that were incorporated into the plan's updated mission, goals, objectives, and mitigation strategies regarding the topic areas of environmental and historic resources, disability services, public health, and infrastructure assets. Table 3-3 shows the current members of the Steering Committee, at the time of this draft Plan's publication.

Members of the Steering Committee (individually and as a whole), as well as key stakeholders including the Assistant County Engineer and Chairman of the Somerset County Energy Council, convened and/or communicated on an as-needed basis to share information and participate in workshops to provide feedback regarding the identification of hazards; assessment of risks; and development of mitigation goals, objectives and actions. The Steering Committee also provided continuity and direction throughout the Plan development process to ensure that natural hazards vulnerability information and appropriate mitigation strategies were incorporated into the Plan. Steering Committee members also supported interaction with other stakeholders and assisted with public involvement efforts.

## STAKEHOLDERS INVOLVED IN MITIGATION PLANNING

This section presents (1) municipal involvement, (2) state and regional agency involvement, (3) public participation – citizen involvement, and outreach to business, utility, educational, non-profits, and other stakeholders.

Diligent efforts were made to assure broad regional, county and local representation in this planning process. To that end, a comprehensive list of stakeholders was developed with the support of the MPC and Steering Committee. Stakeholder outreach was performed early on, and continually throughout, the planning process. In addition to "mass media" notification efforts, identified stakeholders were invited to attend the Kick-Off meeting, while key stakeholders were requested to participate on the Steering Committee and/or in the Focus Group Sessions. Information and input provided by these stakeholders has been included throughout this Plan where appropriate, as identified in the references.

This summary addresses the various stakeholders that were invited to participate in the development of this Plan, and how these stakeholders participated and contributed to the Plan. It should be noted that this summary listing cannot possibly represent the sum total of stakeholders that were aware of and/or contributed to this Plan, as outreach efforts were being made, both formally and informally, throughout the process by the many planning partners involved in the effort, and documentation of all such efforts is impossible. Rather, this summary is intended to demonstrate the scope of the stakeholder outreach efforts made during the development of this Plan.

On November 8, 2018, the PMT sent a notice to all neighboring county emergency management offices and planning divisions/departments indicating that the draft 2019 plan update was available for review and requesting input and comments as appropriate. They were also invited to attend one of the two public meetings on the draft plan. The first will be held as part of the regularly scheduled County Planning Board Meeting on November 20, 2018, and the second will be held on December 5, 2018 at the County's Emergency Services Training Academy.

The 2019 plan update represented the County's first use of a Focus Group approach in conjunction with the mitigation planning process. Four groups were formed with subject matter experts in each of the following sectors: 1) Infrastructure and Utilities, 2) Environmental and Historic Resources, 3) Business and Industry, 4) Public Health. Each Focus Group was convened one time. Discussion topics for each group were identified in order to solicit tangible information needed to shape and complete the updated plan, including the Flood and Energy Resiliency Framework components. Somerset County invited more than 50 stakeholder entities to participate, representing a wide range of private, non-profit, and public sector organizations. Table 3-6 documents the 31 stakeholders who ultimately participated in each Focus Group Session.

A series of questions were defined by the PMT to gain the unique perspective and insights of the different groups of subject matter experts participating in the HMP Update Focus Group Sessions. Discussion topics were identified in order to gather the information needed to shape and complete the updated plan, including the draft Flood and Energy Resiliency Framework components. Each question was preceded by a brief background statement to provide context for the discussion. A total of six questions were set forth to organize the discussion. Ten minutes were allocated per question. Each Focus Group Session was approximately 90 minutes in length. The six questions were:

1. What are some of the major physical improvements/capital investments and planning/policy/regulatory changes you are aware of/or that affect you, which have taken

- place recently by both the public and private sectors to mitigate natural hazards, harden infrastructure and make communities more resilient?
- 2. What are some of the major difficulties faced by vulnerable population groups during natural disasters, and what can we do to reduce their risks as well as improve their access to community public health infrastructure, healthcare and other essentials when hazardous events occur?
- 3. What are some high-priority area-wide and site-specific actions that we can take to leverage resources and maximize opportunities to improve floodplain management, reduce flood risks and strengthen flood resiliency?
- 4. What are the top ten critical facilities for which power reliability is essential; and what can we do to ensure that they can continue to operate in the event of prolonged, wide-spread power outages?
- 5. What can we do to better protect historic and cultural assets, natural/ecological resources and the built environment from natural hazards in the future?
- 6. What are some key adaptation strategies and best practices that Somerset County, its municipalities, residents, businesses and others can implement to become more resilient when facing the impacts of climate change such as more frequent and severe storms; longer, hotter summers: wet and dry spells, etc.?

The Focus Group Sessions provided tangible input and feedback for use by the larger Planning Committee in preparing the Flood and Energy Resilience Framework documents (Appendices K and L of this plan, respectively). They also informed larger mitigation strategy updates for individual participating jurisdictions.

# **Municipal and Local Involvement**

The MHMOs, with support from the PMT and AECOM met and communicated with the members of their MHMCs and other relevant representatives of their respective boroughs/townships to obtain data and information, review existing plans, ordinances and capabilities, and facilitate the identification of appropriate mitigation initiatives. Further, these local representatives have reviewed the Draft Plan and provided direct input during its development.

Throughout the course of updating the HMP, the PMT and AECOM corresponded frequently via telephone, e-mail and in-person meetings with MHMOs and other local representatives to update them on the process, make them aware of important meeting dates, planning tools and resources and other plan The PMT and AECOM also provided copies of meeting materials including review activities. PowerPoint presentations and distribution materials to all members of the MPC, so that members who were unable to attend meetings could remain informed, and to provide resources and guidance documents for future reference. For each of the participating municipalities, the distribution list for formal correspondence from the County included:

- Clerk/Administrator
- MHMOs (Primary Point of Contact)
- Alternate MHMOs (Secondary Point of Contact)

In addition, before finalization of the updated HMP, a webpage link to the entire draft HMP and the applicable jurisdictional annexes were forwarded to MHMOs and Alternate MHMOs with a request that they review the updated HMP and their respective annexes. MHMOs were also directed to provide at least their local annex to their municipal planners, engineers, public works directors, health officers, planning board chairs and floodplain administrators. The MPC both directly and through the PMT met and communicated with NJOEM regularly to obtain mitigation planning information and general guidance for completing the HMP update process. Meeting sign-in sheets which indicate the municipal and stakeholder participants are provided in Appendix I.

At a minimum, these stakeholders were advised of the planning process and provided the opportunity to review and provide direct input to the Plan during its development and/or most recent update. Further, the MPC and/or the PMT and AECOM met and/or directly communicated with many of these stakeholders to obtain data and information, review existing plans, and facilitate the identification of appropriate mitigation initiatives. Specific information obtained from these stakeholders is cited and/or referenced throughout this Plan.

Somerset County government agencies provided input as noted below.

# **Somerset County Government Agencies**

Somerset County Planning Department - The County Planning Division Director served as comanager of the project. He was a member of the MPC, associated PMT and Steering Committee along with two other members of his staff. The Chief of Strategic Planning provided primary project oversight and coordination. Planning Staff facilitated the establishment of the MPC, Steering Committee, PMT, Focus Groups and the associated scheduling, content, format and logistics of all meetings. The Chief of Strategic Planning led the development of the Flood Resiliency Framework and Energy Resiliency Framework, and was responsible for a substantial portion of the associated research, text and "tool kit" matrices. Planning staff played a lead role in the preparation and distribution of formal communications (memorandums, letters and e-mail messages, project fact sheets, invitational flyers, worksheets, etc.) to municipal officials, municipal HMOs, Steering Committee members and other stakeholders. Planning Staff provided technical review and assisted in the completion of all sections of the HMP, and prepared several GIS-based maps for inclusion in the updated Risk Assessment and Flood Resiliency Framework. Planning Staff ensured all county-level worksheet inputs were completed, conferring with members of the PMT, Steering Committee and other County agencies as appropriate; and played a lead role in preparing the projects/actions to be modified and carried forward to the 2019 plan and new projects/actions for inclusion in the updated HMP Mitigation Strategy. Planning staff presented information about the HMP update process at all regularly scheduled meetings of the County Planning Board and the Board's Master Plan/Land Use Committee; as well as at the Planning Partnership Forums for municipal officials, planning staff and planning board members that are held quarterly. Planning Staff also established the electronic project file management system, ensuring all project-related records; including all municipal worksheet inputs and associated correspondence were maintained.

Somerset County Emergency Management Office—The County OEM Director served as co-manager of the project. He was a member of the MPC, associated PMT and Steering Committee along with two other members of his staff. He and his staff played a lead role in facilitating municipal involvement in the completion of the worksheets used for submitting local information needed to update the municipal annexes. They also played a supporting role in organizing the planning process, providing information to stakeholders and opportunities for input during the HMP update process. The County OEM holds quarterly OEM Coordinator Meetings at which the update of the Hazard Mitigation Plan was discussed. The County OEM also kept the Hazard Mitigation Website updated as well as helped facilitate the various MPC, PMT, Steering Committee meetings, Focus Group Sessions and municipal assistance workshops

held throughout the HMP update process. County OEM staff handled submission of quarterly reports to the NJOEM. County OEM staff assisted in determining the implementation status of the county-level 2014 HMP Mitigation Strategy actions/projects; and decisions regarding which projects should be carried forward "as-is" or with modifications and the identification of new projects for inclusion in the 2019 HMP Update. County OEM staff also helped prepare the county-level inputs (worksheet completion) for updating Volume II Section 9, refinement of the drafted updated of the implementation status of the County's 2014 HMP Mitigation Strategy projects and initiatives; and proposed projects and initiatives to be included in the updated HMP. County OEM staff also participated in the review and refinement of the overall draft updated HMP.

Somerset County Department of Engineering – The Assistant County Engineer attended meetings of the MPC. Steering Committee and PMT. He was instrumental in assessing the implementation status of the County's 2014 HMP Mitigation Strategy projects and initiatives; and evaluated those that should be modified and carried forward into the 2019 update as well as potential new projects and initiatives for inclusion in the plan. He also reviewed and provided written feedback on the draft HMP Sections.

Somerset County Department of Public Works - The County Planning Division is within the Department of Public Works. As such, HMP project updates were provided to the Director of Public Works by the County Planning Director at the regularly scheduled monthly department meetings. The Planning Director also met with the Public Works Director on a regular basis to keep him apprised of municipal participation and potential new county mitigation projects/actions and other issues. Director of Public Works was provided a copy of the draft updated HMP for review and comment prior to submission to the NJOEM and FEMA review agencies.

Somerset County Public Information Office – A representative from the County Public Information Office (PIO) served on the Steering Committee, attended steering committee meetings. The PIO representative ensured broad and frequent communication and information to the public using a wide variety of media (Facebook, Twitter, print media, emails, and electronic media). For example, she facilitated the distribution of e-mail communications regarding the HMP update process to members of the County's HMP e-mail service list, which is maintained by the PIO. The PIO also oversees the development of the County e-Newsletter and provides information about the HMP update process therein.

Somerset County Information Technology (IT) Division: The PMT met with the County GIS Coordinator who is a member of this division on several occasions to discuss GIS resources currently available for use in the development of the updated HMP, and for technical guidance with regard to certain GIS-dependent 2014 actions/projects that were modified and carried forward for inclusion in the 2019 HMP Update. The County GIS Coordinator participated in the preparation of the county-level inputs (worksheets) associated with completion of Volume II, Section 9 of the HMP. The County GIS Coordinator developed a GIS On-line Tax Parcel Viewer which allows members of the public and other interested individuals the ability to see how FEMA's mapped flood hazard area information affects individual properties. which available following is the http://gis.co.somerset.nj.us/somersetco\_tpv/. The County Planning Division's Senior Planner-GIS who collaborates closely with the County GIS Coordinator, provided GIS technical assistance in the development of the updated HMP, including the provision of GIS-based maps utilizing FEMA's FIRM, SRL and RL data in combination with data maintained by New Jersey Department of Environmental Protection and the County Planning Division.

Somerset County Human Services Department- Julie DeSimone, Planning Administrator for the Department of Human Services served as a member of the Steering Committee. She attended several Steering Committee Meetings and was actively engaged in preparing the county-level input documents

(worksheets) needed for completing the updated HMP. She also reviewed and provided feedback on each of the updated draft HMP components.

#### Commercial and Industrial Interests

The President and CEO of the Somerset County Business Partnership (SCBP) serves as a member of the Steering Committee and has been involved in the Steering Committee Meetings as well as participated in the review of the draft updated HMP components. The SCBP's Director of Workforce Development served as HMP Focus Group participant. A Comprehensive Economic Development Strategy for Somerset County (CEDS) was developed for the County in accordance with USEDA standards and adopted as an element of the Somerset County Master Plan in 2014 through a collaborative effort involving the Somerset County Business Partnership and the County Planning Division. The aftermath of Superstorm Sandy significantly influenced this plan (a summary of the economic impacts resulting from this storm is included therein). The CEDS recognizes the important role hazard mitigation plays in terms of protecting the economy and promoting economic growth, therefore, *Hazard Mitigation* is included as a "Secondary Focus Area", along with recommended mitigation projects. An update of the CEDS is scheduled to take place during 2019 through a joint effort involving the County Business Partnership and Planning Division. One of the CEDS projects involved flood protection improvements at the NJ American Water Supply Company treatment works in Bridgewater, which was implemented in 2016-2017. Expanded integration of hazard mitigation planning within the CEDS will be pursued during the CEDS update process.

## **Public Participation - Citizen Involvement**

In order to facilitate better coordination and communication between the MPC and citizens and to involve the public in the planning process, it was determined that draft documents will be made available to the public through a variety of venues. The participating partners feel that providing a Plan that is in a printed form (in addition to an online format) is valuable because it is familiar, even reassuring, to citizens who have been part of a comprehensive planning process and have suffered losses due to a hazard. Some citizens also may not be comfortable with online tools or may not have internet access. The participating partners also feel that community input in the HMP update will increase the likelihood of hazard mitigation becoming one of the standard considerations in the evolution and growth of the County.

The MPC has made the following efforts to inform and engage the public in the development and review of the updated HMP:

- The public was informed of the hazard mitigation planning effort commencement at the kick-off meeting, and through press releases, news articles, and public service announcements. In addition, 1,100 e-mail subscribers to the County's Multi-jurisdictional Hazard Mitigation Plan service list received information about the update of the HMP. In addition to informing the communities and the public of the ongoing planning effort, updates regarding the mitigation planning process have been made at County Municipal Emergency Management Coordinators meetings, and at the Somerset County Police Chiefs Association meetings.
- County Planning Division staff reported on mitigation plan update progress at each regularly scheduled County Planning Board meeting conducted throughout the 2019 HMP update project timeline. All Planning Board meetings are open to the public. Planning Division representatives solicited input and feedback from those in attendance at each meeting.
- A public Hazard Mitigation webpage on the Somerset County website is being maintained as another way to facilitate communication between the Planning Committee and County residents (https://www.co.somerset.nj.us/government/public-health-safety/hazard-mitigation). The Hazard Mitigation webpage has been consistently maintained since the initial HMP's development, although it was reformatted and its address was changed in 2016 as part of a comprehensive update of the The webpage contains a project overview, MPC contact information, the overall County website.




Figure 3-1. Screenshot of the Hazard Mitigation Plan Link on the Somerset County Government Website




Figure 3-2. Screenshot of the Somerset County Hazard Mitigation Plan Public Comment Website

- current HMP, and sections of the updated 2019 HMP for public review and comment. See Figures 3-1 and 3-2 for screenshots of this public website.
- Links to the public webpage have been established by the Township of Bedminster and Boroughs of Manyille and North Plainfield, and are posted on the websites of those towns. All municipalities have been requested to post a link to the Hazard Mitigation webpage to provide ongoing public outreach.
- The public has been informed of the mitigation planning process through media coverage and articles appearing throughout the planning process. It is noted that all press releases were emailed to approximately 6,227 people (which includes Disaster Relief subscribers in addition to What's New). There are approximately 2,473 subscribers to the County e-newsletter and about 3,904 Facebook subscribers and over 1,075 followers on Twitter. Copies of these articles may be found in Appendix
- In order to facilitate coordination and communication between the MPC and citizens, and involve the public in the planning process, the updated HMP will be made available to the public through a variety of venues. A printed version of the Plan will be maintained at Somerset County Planning Office and public libraries throughout the County.
- The County has created a page on its website devoted to the Multi-Hazard Mitigation Plan (https://www.co.somerset.nj.us/government/public-health-safety/hazard-mitigation) to inform residents of the project and allow for direct input. The website initially went live during the previous plan update in March 2012 at a predecessor address http://www.co.somerset.nj.us/hazard/index.htm. While the address has changed, and the format and content have been updated over time, the page itself has been maintained on a continuous basis to provide information on the project and methods the public can participate in the planning process (Appendix C), including via submittal of public comments online at https://www.co.somerset.nj.us/government/public-health-safety/hazardmitigation/public-comments.
- The first update cycle that led to the completion of the 2014 HMP included an online natural hazards preparedness citizen survey, which was used to gauge household preparedness and assess the level of knowledge of available tools and resources that can assist them in reducing hazard risks and potential losses. The questionnaire asked quantifiable questions about citizen perception of risk, knowledge of mitigation, and support of community programs. It also asked several demographic questions to help analyze trends. On August 8, 2012, a press release was issued announcing the project and promoting participation in the online survey. Reponses were collected and incorporated into the 2014 HMP's Strengths, Weaknesses, Opportunities, and Obstacles (SWOO) discussions and the catalog of mitigation actions.
- A press release was issued on August 23, 2017, announcing that the Plan Update was underway, and once again requesting public participation. # COORDINATION WITH EXISTING PLANNING EFFORTS AND PROGRAMS

Local municipalities are charged with the development of local HMPs required under Section 322 of the Stafford Act by New Jersey. Therefore, the MPC, with resources and assistance from the County, coordinated the development and update of this HMP. In New Jersey, local municipalities are authorized to prepare local disaster plans based on the contention that they are best equipped to assess their strengths and weaknesses, opportunities, and constraints. Local governments have intimate knowledge of the local geography, and in a disaster, local government personnel are on the front lines providing personnel and equipment to support the community. Somerset County and its participating jurisdictions are involved in this above program, hence the development of this Plan.

Examples of other hazard mitigation programs within Somerset County include the National Flood Insurance Program (NFIP), and the Hazard Mitigation Grant Program (HMGP). These programs assist the County and its municipalities in receiving funding for flood mitigation projects and flood insurance (the HMGP also can provide funds to mitigate other natural hazards). Data from the County, based on participation in these programs, was incorporated in the risk assessment in Section 5 and used to identify mitigation options in Section 9. Continued involvement in these flood-related programs will help to administer funds and resources to support this HMP.

An overview of various program funding opportunities is provided in the following subsections; note, however, that further information on a wider range of both state and federal funding streams is included in Appendix E, the Flood Resiliency Framework and Energy Framework components of the HMP.

# **Federal Hazard Mitigation Funding Opportunities**

Federal mitigation grant funding (Stafford Act 404 and 406) is available to all communities with a current hazard mitigation plan (this plan); however most of these grants require a "local share" in the range of 10-25% of the total grant amount. Participation in FEMA 404 HMGP may cover mitigation activities including raising, removing, relocating or replacing structures within flood hazard areas. The FEMA mitigation grant programs are described below.

# **Hazard Mitigation Grant Program (HMGP)**

The HMGP is a post-disaster mitigation program. It is made available to states by FEMA after each Federal disaster declaration. The HMGP can provide up to 75% funding for hazard mitigation measures. The HMGP can be used to fund cost-effective projects that will protect public or private property in an area covered by a federal disaster declaration or that will reduce the likely damage from future disasters. Examples of projects include acquisition and demolition of structures in hazard prone areas, floodproofing or elevation to reduce future damage, minor structural improvements and development of state or local standards. Projects must fit into an overall mitigation strategy for the area identified as part of a local planning effort. All applicants must have a FEMA-approved Hazard Mitigation Plan (this plan).

Applicants who are eligible for the HMGP are state and local governments, certain nonprofit organizations or institutions that perform essential government services, and Indian tribes and authorized tribal organizations. Individuals or homeowners cannot apply directly for the HMGP; a local government must apply on their behalf. Applications are submitted to NJOEM and placed in rank order for available funding and submitted to FEMA for final approval. Eligible projects not selected for funding are placed in an inactive status and may be considered as additional HMGP funding becomes available.

# Flood Mitigation Assistance (FMA) Program

FMA provides funding to assist states and communities in implementing measures to reduce or eliminate the long-term risk of flood damage to buildings, manufactured homes, and other structures insurable under the NFIP. The FMA is funded annually; no federal disaster declaration is required. Only NFIP insured homes and businesses are eligible for mitigation in this program. Funding for FMA is very limited and, as with the HMGP, individuals cannot apply directly for the program. Applications must come from local governments or other eligible organizations. The federal cost share for an FMA project is 75%. At least 25% of the total eligible costs must be provided by a non-federal source. Of this 25%, no more than half can be provided as in-kind contributions from third parties. At minimum, a FEMA-approved local flood mitigation plan is required before a project can be approved. FMA funds are distributed from FEMA to the state. NJOEM serves as the grantee and program administrator for FMA.

# **Pre-Disaster Mitigation (PDM) Program**

The PDM program is an annually funded, nationwide, competitive grant program. No disaster declaration is required. Federal funds will cover 75% of a project's cost up to \$3 million. As with the HMGP and FMA, a FEMA-approved local Hazard Mitigation Plan is required to be approved for funding under the PDM program.

# Repetitive Flood Claims (RFC) Program

The RFC program is an annually funded, nationwide mitigation grant program with the goal of reducing flood damages to individual properties for which one or more claim payments for losses have been made under flood insurance coverage, and will result in the greatest amount of savings to the National Flood Insurance Fund (NFIF) in the shortest period of time. RFC funding is available for property acquisition and structure demolition or relocation, structural elevations, and minor localized flood reduction projects. Federal funding covers 100% of the project costs.

# Severe Repetitive Loss (SRL) Program

The SRL program is an annually funded, nationwide mitigation grant program with the goal of reducing flood damages to residential properties that have experienced severe repetitive losses under flood insurance coverage, and as such, will result in the greatest amount of savings to the NFIF in the shortest period of time. SRL funding is available for property acquisition and structure demolition or relocation, structural elevations, and minor localized flood reduction projects. Federal funding covers 75% of the project costs (90% if the community has a repetitive loss strategy).

## **Federal Disaster and Recovery Assistance Programs**

Following a disaster, various types of assistance may be made available by local, state and federal governments. The types and levels of disaster assistance depend on the severity of the damage and the declarations that result from the disaster event. Among the general types of assistance that may be provided should the President of the United States declare the event a major disaster are the following:

#### **Individual Assistance (IA)**

IA provides help for homeowners, renters, businesses and some non-profit entities after disasters occur. This program is largely funded by the U.S. Small Business Administration. For homeowners and renters, those who suffered uninsured or underinsured losses may be eligible for a Home Disaster Loan to repair or replace damaged real estate or personal property. Renters are eligible for loans to cover personal property losses. Individuals may borrow up to \$200,000 to repair or replace real estate, \$40,000 to cover losses to personal property, and an additional 20% for mitigation. For businesses, loans may be made to repair or replace disaster damages to property owned by the business, including real estate, machinery and equipment, inventory and supplies. Businesses of any size are eligible. Non-profit organizations such as charities, churches, private universities, etc. are also eligible. An Economic Injury Disaster Loan provides necessary working capital until normal operations resume after a physical disaster. These loans are restricted, by law, to small businesses only.

# **Public Assistance (PA)**

PA provides cost reimbursement aid to local governments (state, county, local, municipal authorities and school districts) and certain non-profit agencies that were involved in disaster response and recovery programs or that suffered loss or damage to facilities or property used to deliver government-like services. This program is largely funded by FEMA with both local and state matching contributions required.

# **Community Development Block Grants (CDBG)**

CDBG are federal funds intended to provide low and moderate-income households with viable communities, including decent housing, as suitable living environment, and expanded economic Eligible activities include community facilities and improvements, roads and opportunities. infrastructure, housing rehabilitation and preservation, development activities, public services, economic development, planning, and administration. Public improvements may include flood and drainage improvements. In limited instances, and during the times of "urgent need" (e.g., post disaster) as defined by the CDBG National Objectives, CDBG funding may be used to acquire a property located in a floodplain that was severely damaged by a recent flood, demolish a structure severely damaged by an earthquake, or repair a public facility severely damaged by a hazard event.

## **National Flood Insurance Program**

Established in 1968, the NFIP provides federally-backed flood insurance to residents of communities that enact and enforce regulations that more carefully regulate development within floodplain areas. For individual property owners to be eligible to buy the federally-backed flood insurance, their property must be located within a community that participates in NFIP.

There are three components to the NFIP: flood insurance, floodplain management, and flood hazard mapping. Communities participate in the NFIP by adopting and enforcing floodplain management ordinances to reduce future flood damage. In exchange, the NFIP makes federally backed flood insurance available to homeowners, renters, and business owners in these communities. Community participation in the NFIP is voluntary. Flood insurance is designed to provide an alternative to disaster assistance to reduce the escalating costs of repairing damage to buildings and their contents caused by floods. Flood damage in the U.S. is reduced by nearly \$1.1 billion each year through communities implementing sound floodplain management requirements and property owners purchasing flood insurance (FEMA, 2018). Additionally, FEMA has estimated that buildings constructed in compliance with NFIP building standards suffer approximately 80% less damage annually than those not built in compliance.

For a community to be eligible to participate in the NFIP, it must adopt and enforce a floodplain management ordinance to regulate proposed development in floodplains and officially designate a local floodplain coordinator/administrator. The intent of the program is to ensure that new construction and substantial improvements do not exacerbate existing flood hazards and is designed to better withstand flooding. All jurisdictions in Somerset County participate in the NFIP. The communities also have Flood Insurance Rate Maps (FIRMs) that, at a minimum, show the FEMA Special Flood Hazard Areas

(SFHAs). Mitigation activities related to this program are included in Section 9 and data from FEMA Region 2 regarding NFIP Insurance Reports was used in the risk assessment for the flood hazard included in Section 5.

Each municipality in Somerset County participates in FEMA's NFIP and, as such, has designated a local floodplain administrator (sometimes referred to as a local floodplain manager) in their respective floodplain management ordinances, whose role it is to administer and enforce the terms of the local ordinance. Floodplain administrators have been informed of, and engaged in, the mitigation planning process. They have reviewed the plan documents, and provided direct input to the Plan, including this 2019 plan update. Table 3-8 summarizes the designated Floodplain Administrators for each jurisdiction.

# **Community Rating System (CRS)**

The NFIP has been successful in protecting property owners who acquire flood insurance through the program from catastrophic financial losses due to flooding, and in requiring that new buildings constructed within 100-year floodplains are better protected from flood damage.

In the 1990s, the Flood Insurance Administration (FIA) established the CRS to encourage local governments to increase their standards for floodplain development. The goal of this program is to encourage communities, through flood insurance rate adjustments, to implement standards above and beyond the minimum required in order to:

- Reduce losses from floods
- Facilitate accurate insurance ratings
- Promote public awareness of the availability of flood insurance

CRS is a voluntary program designed to reward participating jurisdictions for their efforts to create more disaster-resistant communities using the principles of sustainable development and management. Five Somerset County communities are currently participating in the program, but several others are considering or have started the process of enrolling in CRS as indicated in their annexes in Section 9 of this plan. By enrolling in CRS, county municipalities can leverage greater flood protection while receiving flood insurance discounts. Active involvement in this program is included as mitigation activities in several of the municipal annexes in Section 9.

Below is a summary of CRS ranking for participating communities in the county as of October 2017.

The Borough of Manville applied for a FMA Planning Grant in 2015 and received funding to prepare an Acquisition Action Plan, which is part of the Borough's updated Annex. This plan includes an evaluation of structures in the flood-prone areas of the Borough that are suitable for acquisition and a prioritized mitigation strategy. This plan will be used as the basis for future FEMA Hazard Mitigation Assistance Grant funding to be pursued by the Borough to acquire repetitive loss properties and eliminate associated future flood risk. The Borough has recently expanded its CRS activities and is currently seeking a CRS 5 classification which would increase its SFHA discount to 25%.

# **Somerset County Emergency Operations Plan**

The County plans to include the addition of an environmental component to the Somerset County Emergency Operations Plan that responds to the information provided in the Climate Memorandum, and draft Flood Resiliency and Energy Resiliency Framework documents included in the Appendix. Issues such as inclusion of possible development of more aggressive household and small business hazardous waste management techniques (creation of ordinances, public education, County Household Hazardous Waste Days held in these communities, etc.) in flood prone areas shall be addressed in the Emergency Operations Plan.

- FEMA "How To" Series (386-1 to 386-4, and 386-7)
- Public laws and other programs such as the NFIP were examined to complete this Plan.

A complete list of the existing data and plans used to support this HMP is included in the references section of this document. By incorporating data from existing programs into this mitigation plan, the County and jurisdictions also were able to identify the relevance of mitigation planning to these existing

programs. Implementation of this Plan through these existing plans is identified as a specific mitigation action in several areas in Section 9 of this Plan.

Additional meetings may also be held as deemed necessary by the MPC. The purpose of these meetings would be to provide the public an opportunity to express concerns, opinions, and ideas about the HMP.
