Approval of Minutes

Richard Norz informed staff that his name was incorrectly omitted from the June CADB Minutes. A motion to approve the minutes with the change was made by Richard Norz and was seconded by Peter Staats. The motion was passed and carried.

Public Comment

Dave Marek from the Somerset County Patriots attended the meeting to discuss plans for the "Garden State Ag Night" on August 15, 2019 at the Patriots Ballpark. Mr. Marek explained plans for a petting zoo, farmer's market tables, and farm equipment displays.

He explained that he was seeking direction from the CADB. The Board agreed to have a table representing the CADB at the event and also would handout materials about it at the upcoming Somerset County 4-H fair. They also suggested speaking with the NJ Farm Bureau and the Somerset County Board of Agriculture.

I-2) Somerset County Preservation Plan – Update

Walter Lane informed the Board that a public meeting for the Somerset County Preservation Plan was held on June 26, 2019. He explained that staff has received ten written comments throughout the comment period and that GIS staff is continuing to work on the data and mapping.

Richard Norz again spoke that wildlife control and noxious weeds are serious issues and should be addressed in the plan. The Board discussed the issue stating that fields should need to be mowed off by June 15th and that management practices need to be put in place.

Staff indicated that their concern was discussed previously and will be given attention in the final plan. A motion for staff to summarize the discussion and submit the comments for the Somerset County Preservation Plan was made by Richard Norz and was seconded by Ed Seidel. The motion was passed and carried.

Kate explained that she will have the summary available for the Board's review for the next meeting.

I-3) SADC Meeting Update

Amy Mandelbaum attended the meeting and provided the Board with an update from the last SADC Meeting. She reviewed the Somerset County properties that are currently under review and shared the monthly newsletter.

I-4) County/State Boards of Agriculture

County: The Board was informed that the annual Agriculture Picnic was going to be held on July 28, 2019.

State: The Board was informed that the next state Board of Agriculture meeting is to be held on July 24, 2019. Richard Norz also explained that there are two members coming off the Board and there will be two new members appointed.

I-5) 4-H Fair

Plans for the upcoming 2019 4-H fair were discussed.

D-1) Potential Projects

Kate Katzer informed the Board that staff met with owners of the Montefusco Farm. She explained that there has not yet been an application submitted and that they only discussed potential options.

Staff informed the Board that the Gund application was on the SADC agenda for final approval on June 25, 2019.

D-6) Harms (Bedminster)

Staff informed the Board that there are plans for a shed being placed on the Harms property. The Board was provided with information in their packets and they agreed to discuss in closed session.

D-7) Closed Session

A motion to enter Closed Session was made by Peter Staats and was seconded by Ed Seidel. The motion was passed and carried and he Board entered Closed Session.

Jay Johnson was not present during any discussions regarding Hunter Farms and Walter Lane was not present during any discussions regarding the Patel Property.
