#### **OLD BUSINESS:**

<u>FY 2020 Annual Audit Update</u> – Frank Calo reported that the District's auditor was unable to return prior to the October meeting to complete the FY2020 Audit. The auditor is scheduled to visit the District office on October 22<sup>nd</sup>. The District will notify the State Soil Conservation Committee that the filing of the audit will be delayed until mid-November. The Board was informed that as soon as a draft of the audit was completed, they would receive a copy. The hope is that the District audit can be voted on at the next meeting on November 18th and if approved forwarded to the State.

#### **NEW BUSINESS:**

<u>2021 NJ Conservation Poster Contest</u> – Frank Calo informed the Board that the District had received the flyer for the 2021 NJ Conservation Poster Contest. This year's theme is "Healthy Forests, Healthy Communities" The flyer will be posted on the District's webpage. Copies will be sent to the School Superintendents of both counties so that they can be distributed to the various school districts.

<u>2021 NACD Membership Dues</u> – Frank Calo informed the Board that the District had received an invoice for the FY 2021 NACD dues. Bob Amberg made a motion to pay the \$501.00 dollar dues for FY 2021 to the NACD. The motion was seconded and unanimously passed by the Board.

<u>2020 NJACD Annual Conservation Partnership Meeting</u> – The Board was informed that this year's NJACD Annual Partnership meeting will be held virtually on Monday November 16, 2020. Board members received a draft copy of this year's conference agenda, as well as, the NJACD 2021 Budget, for review. Frank Calo informed the Board that the final agenda and additional information would be forthcoming. The District Manager reminded the Board that their attendance was required in fulfilling the District Supervisor performance standards.

<u>District Action on Chapter 251</u> – Jim Laine made a motion to approve the plans on the attached certified and completed list. The motion was seconded and approved by the Board. Ed Dec recused himself from voting on application 2018-3654 and 2019-3882 on the completed list. Matt Loper recused himself from voting on applications 2018-3073, and 2019-3651, on the completed list and 2020-4362, and on the certified list.
