Somerset County Office on Aging & Disability Services Reopened Its Senior Wellness Centers

SOMERVILLE, NJ – The Somerset County Office on Aging and Disability Services reopened

its senior wellness centers on a trial basis, after serving clientele via virtual programs, outdoor activities, and curbside lunch programs throughout the pandemic. Senior centers resumed in-person activities on March 2 with exciting grand reopening themed-events throughout the month. Senior center clientele must comply with COVID restrictions and registration is required.



"We have been eagerly anticipating the reopening of in-person activities at the centers for almost two years," said Somerset County Commissioner Director Shanel Y. Robinson. "These programs are a vital part of many seniors' lives by helping them to stay emotionally connected and physically healthy. We are excited that the time has finally come for us to begin returning to normal."

A series of special events including music, activities, and food are occuring; and culminating in May, recognizing Older Americans Month. A list of dates, locations and entertainment is available online or at the senior wellness centers.

"We are finally easing our way back into normalcy and are excited to welcome the return of our seniors at the centers," said Somerset County Commissioner Paul M. Drake. "Our dedicated staff persevered and adapted very quickly during COVID, making it possible for us to provide virtual programs during the pandemic. The staff has really missed seeing clients in person."

Registration Is Required

The clientele must register in advance and provide proof of vaccination or show county-approved exemption.

COVID Restrictions

The Office on Aging and Disability Services continues to follow state-mandated public healthcare guidelines and is committed to providing a safe environment for its staff and clientele; therefore, senior centers will begin reopening on a trial basis. Clientele will be required to wear face masks and maintain social distance while at the senior centers.

Lunch at the Senior Centers

All county-operated senior centers will offer a nutritionally balanced lunch on Monday, Wednesday, and Friday, for a suggested donation of \$2.50. Lunch registration is required before 10 a.m. on the previous business day. Menu choices include a hot meat-based or meatless entrée or a cold meat-based or meatless boxed lunch.

Virtual Programs and Grab & Go Lunch

Zoom activities will continue to be available each month. Grab & Go lunch programs are also still offered at all locations on Tuesdays and Thursdays, and to all seniors regardless of their vaccination status. Announcing Big Savings for Eligible NJ Seniors



Dear New Jersey Resident Age 65+,

We are pleased to announce that Governor Murphy's Fiscal Year 2022 Budget has raised the annual income limits of two statefunded prescription drug benefit programs by \$10,000.

- Pharmaceutical Assistance for the Aged and Disabled (PAAD)
 - **¤** Pay **\$5** or **\$7** for covered prescriptions
 - ¤ The program may also pay your Medicare Part- D monthly premium
 - **¤** For residents age 65+ with incomes up to **\$38,769** if single, **\$45,270**, if married
- Senior Gold Prescription Drug Discount Program
 - **¤** Cut your prescriptions costs in half after a **\$15** co-play
 - **¤** For residents age 65+with incomes up to **\$48,769** if single, **\$55,270** if married*

Part C Plans May Offer Additional Benefits

Most Medicare Advantage plans provide prescription drug coverage. Some Medicare Advantage plans may provide extra benefits such as:

- Routine dental and vision coverage
- Non-emergency transportation
- Home modifications to help you age in place

Individual plan benefits and availability can vary depending on where you live and the type of Part C plan you have. Not all of these extra benefits will be available with Medicare Advantage plans in all areas.
