

# GENERAL INFORMATION & POLICIES

- DASH operates Monday through Friday only
- DASH is public transportation and everyone is eligible to use it.
- The fare for DASH is \$2.00 for a one way ride. Drivers cannot make change, so exact fare is required in dollar bills or coins. Children age 5 and under ride free if accompanied by an adult.
- Tickets are available in advance, at face value, from your driver or by contacting Somerset County Transportation.
- All buses are accessible and the drivers will assist any customer who may need assistance getting on or off the bus.
- Bus route is subject to change due to weather conditions, roadway construction or other unforeseen circumstances.
- Route deviation service is available where conditions allow. Limit of one deviation per trip will be allowed. Riders must call Somerset County Transportation 24 hours in advance at (908) 231-7115. Somerset County Transportation reserves the right to authorize appropriate route deviation requests, subject to local regulations.
- **Drivers cannot make unscheduled route changes.**
- Service provides rural transportation under the S5311 service.

## **Please be considerate of others by observing the following rules:**

- No smoking, drinking, eating or littering
- Speak softly when using cell phones
- Use ear phones when listening to audio equipment.
- Footwear and shirts are required

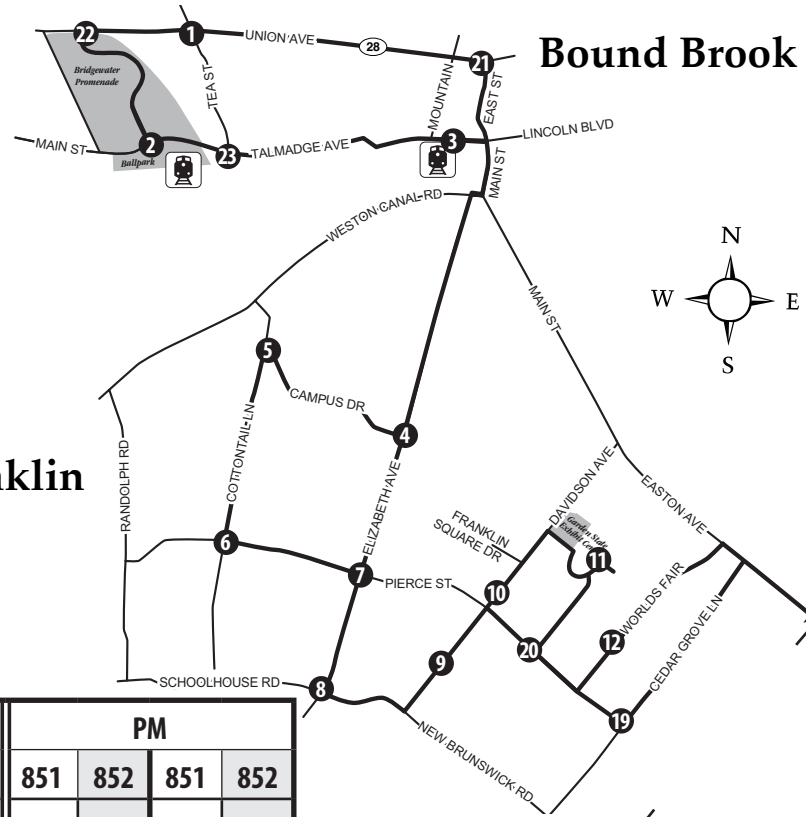

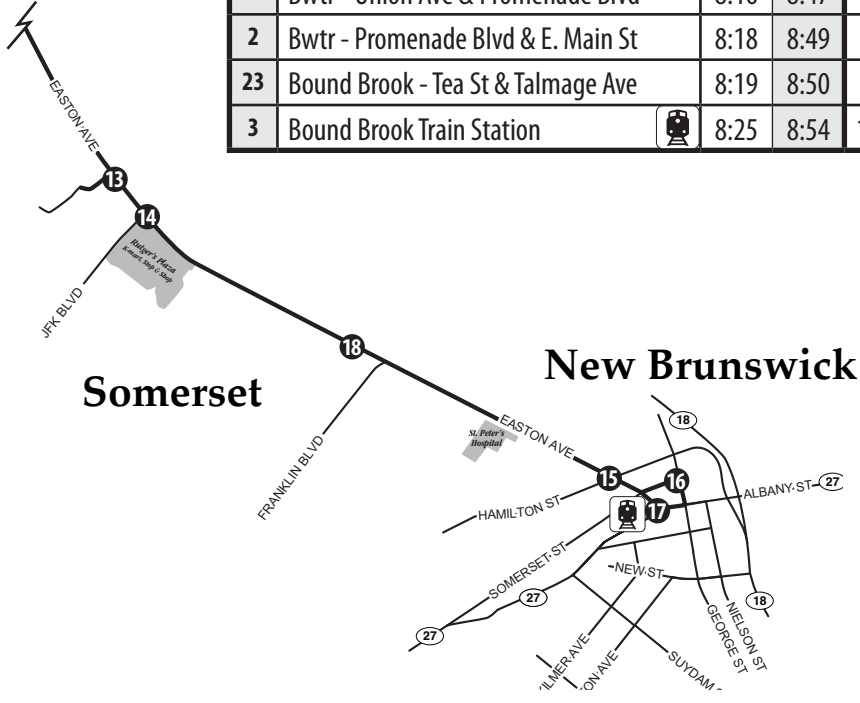
