There are 57 grant funded Family Success Centers in New Jersey. The centers began in 2007 in New Jersey. The purpose of the centers is to establish a neighborhood gathering place and strengthen neighborhoods and families. The focus is on primary prevention with a strengths-based approach. Each center has a **Parent Advisory Board** which represents various cultures in the community. They are comprised of community members and influence the development of activities and programs/services. There is no needs testing for services.

#### **Human Services Director's Report – Mike Frost**

The Human Service Divisions have completed their submissions for the 2023 budget. Staff vacancies at Richard Hall have been reduced, although still higher than desired. Staffing at other HS Divisions have improved as well. We have received permission to provide some supplemental funding from ARP to some of our non-profit agencies who utilized their previous allocations and are in need of extra data driven support.

### VI. New Business

Rheanah Johnson- The Executive/Advocacy/Legislative Committee is currently collecting information via survey for an internal contact database. The purpose is to compile a list of participating agencies and to establish a reliable point for contact for information and referral purposes. Members and guests are encouraged to fill out the survey.

### VII. Agency Highlights/ Announcements

- Kim Cowart The annual point in time survey is scheduled for Wednesday, January 25, 2023. This is the date we try to capture census or snapshot of all of those experiencing homelessness in the county. We send a survey that agencies use to upload information regarding people they are aware of that are experiencing homelessness on the night of January 24, 2023. More information will be shared as the date gets closer.
- Meg Isbitski- Rutgers IBHC has opened their Early Intervention Support Services program (EISS). The program is for any resident in Somerset County that is 18 and older who is trying to access mental health services quickly. The program is for people who are not at the level to be seen by Psychiatric Emergency Screening Services (PESS) but are looking for short-term therapy, medication, support groups, and connection to longer term services. The purpose of the program is to alleviate the need for individuals to go to the hospital or having to contact PESS. Representatives will be presenting at the December 5, 2022, PAC/PACADA meeting. There will be a brick-and-mortar location in Manville with an opening date TBD. Currently individuals are being seen at the location in Piscataway and via telehealth. - Mark Avery- Zarephath Christian Church is still collecting Christmas presents for families. The church can absorb about 70 gifts across a distribution of ages and genders. If you have families who need gifts, please contact <a href="mayery@zcc.live">mayery@zcc.live</a>.
- Paul Grzella- All the career offices are now open for walk-in services. Appointments are encouraged. The unemployment office is not returning to Somerville or Hunterdon County. Appointments can be made online at various locations in NJ. Please be advised the waits are long.
