AN ORDINANCE ESTABLISHING SPEED LIMITS ALONG ORCHARD ROAD, RIVER ROAD, MILLSTONE RIVER ROAD, MAIN STREET, COUNTY ROUTE 533, MONTGOMERY TOWNSHIP, HILLSBOROUGH TOWNSHIP, MILLSTONE BOROUGH SOMERSET COUNTY, NEW JERSEY

BE IT ORDAINED by the Board of County Commissioners of the County

of Somerset that:

SECTION I. Speed limits for both directions of traffic along Orchard Road, River Road, Millstone River Road, Main Street, County Route 533, in Montgomery Township, Hillsborough Township, Borough of Millstone shall be established as follows;

ZONE 1. 35 MPH from State Route 206 to a point 1705 feet north of Bridgepoint Road.

ZONE 2. 45 MPH from a point 1705 feet north of Bridgepoint Road to a point 7826 feet north of Blackwells Mills Road, also known as the Hillsborough/Millstone corporate line.

ZONE 3. 35 MPH from a point 7,826 feet north of Blackwells Mills Road, also known as the Hillsborough/Millstone corporate line, to Yorktown Road.

ZONE 4. 25 MPH from Yorktown Road to Amwell Road County Route 514

ZONE 5. 35 MPH from Amwell Road County Route 514 to Somerset County Courthouse Road, County Route 533 – Bypass.

SECTION II. Regulatory and Warning signs, conforming to the current Manual on

Uniform Traffic Control Devices for Streets and Highways, shall be

erected and maintained to effect the above-designated speed limits.

SECTION III. This ordinance shall take effect upon final passage and publication as

required by law and upon approval by the Somerset County Engineer.

BE IT FURTHER ORDAINED that all previous ordinances or resolutions establishing speed limits on the aforementioned roadway(s) or portions of the roadway(s) herein described are hereby repealed.

RESOLUTION TO EXCEED THE COUNTY BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14) AND SETTING THE PUBLIC HEARING FOR TUESDAY, MAY 23, 2023 AT 6:00PM.

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.2 et seq., provides that in the preparation of its annual budget, a county shall limit any increase in said budget to 2.5% or the cost of living adjustment, whichever is less, unless authorized by resolution to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a county may, when authorized by resolution, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and

WHEREAS, the Board of County Commissioners of the County of Somerset in the County of Somerset finds it advisable and necessary to increase its CY 2023 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the current and future health, safety and welfare of the citizens; and

WHEREAS, the Board of County Commissioners hereby determines that a 3.5% increase in the budget for said year, amounting to \$4,034,178.81 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and

WHEREAS, the Board of County Commissioners hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW, THEREFORE, BE IT ORDAINED, by the Board of County Commissioners of the County of Somerset, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2023 budget year, the final appropriations of the County of Somerset shall, in accordance with this resolution and N.J.S.A. 40A: 4-45.14, be increased by 3.5%, amounting to \$5,647,850.34 and that the CY 2023 county budget for the County of Somerset be approved and adopted in accordance with this resolution; and

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and

BE IT FURTHER ORDAINED, that a certified copy of this resolution as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and
