- Prioritize safety, equity, and resilience











Key Takeaways from Outreach

- More transit
- Enhanced connectivity for walking and bicycling (first/last mile; downtowns; shopping; schools; parks)
- Impacts of increased truck traffic and conflicts at rail crossings
- Need to prepare for storms and weather events
- Improve information and traveler experience
- Changes in demographics and travel patterns





- Review and update County Housing Element
- Leverage the land development review to achieve plan goals

Strengthen Land Use-Transportation Connections: Affordable Housing Site Selection

Key Finding: Disconnect between housing locations and transportation access and opportunities

Reinforce critical link between access and affordable housing and encourage local partners to integrate land use and transportation needs in affordable housing locational decisions

Potential criteria to better inform locational decisions

- Bicycle Level of Stress and Connectivity Analysis
- Demographics and Equity Factors
- WalkBikeHike Framework Strategy
- Access and quality of Complete Streets and transit networks
- Proximity and access to parks and greenways



Strengthen Land Use-Transportation Connections: Land Use & Transportation Strategies

- Establish/expand mixed-use zoning and Transit Oriented Development (TOD)
- Promote use of Accessory Dwelling Units (ADUs)
- Prioritize infrastructure investments in mixed-use districts
- Pursue targeted Access Management Plans
- Leverage land development review process for mobility connections
- Incorporate the use of green infrastructure

- U.S. Route 206 Corridor South: Bypass to Montgomery/Rocky Hill/ CR 518

- River Crossings Resiliency Study
- U.S. 206 Hillsborough Main Street
- Reimagine Somerset County Transit Study
- Regional Freight and Goods Movement Strategy











Freight and Goods Movement Strategy

Countywide or subarea Goods Movement Analysis

Map location of existing and approved warehousing locations

Freight Strategies

- Increase sharing of intermodal freight between truck and rail
- Work with municipal partners to strengthen the land use-transportation connection
- Conduct a study of Warehousing and Goods Movement in Somerset County

Develop and Advance Projects

- Preferred alternative from Port Reading Secondary Grade Crossing Elimination Study
- Freight railroad crossings improvements from NJTPA recent grade crossing study
