OLD BUSINESS:

Stop Work Order Follow-up (Warren, NJ)-Matthew D'Alessandro reported that a recent Stop Work Order in Warren, NJ has been rescinded after the project gained compliance and has been issued a Final Report of Compliance.

NEW BUSINESS:

<u>District Action on Ch. 251-</u> The SUSCD Board reviewed the certified and completed projects for the dates from 11/12/23 to 12/12/23. Ed Dec recused himself from SUSCD File#2023-6277 from the certified list and SUSCD File#2020-4434 and SUSCD File#2023-5795 from the completed list. Ed Dec made a motion to approve the plans on the certified and completed list for the period of 11/12/23 to 12/12/23. The motion was seconded by Bob Amberg and unanimously passed.

<u>Chapter 251 Surcharge Invoice</u>-Matthew D'Alessandro presented a Chapter 251 Surcharge invoice from the NJDA for the 3rd Quarter FY 23 in the amount of \$3,850.00. Jim Laine made a motion to pay the invoice as presented. The motion was seconded by Ed Dec and unanimously passed.

<u>NEACD Employee's Association Donation Form</u>-Matthew D'Alessandro presented a donation form received from the Northeast Association of Conservation Districts. Bob Amberg made a motion to donate \$100.00. The motion was seconded by Jim Laine and unanimously passed.

<u>SSCC/NJDA Partnership Conference</u>-Matthew D'Alessandro informed the Board the annual conference was held on 11/20/23 at the Rutgers Eco Complex in Bordentown, NJ. It was well attended and offered training for the staff in addition to the annual business meeting and other sessions.

<u>2024 SUSCD Meeting Dates</u>-Matthew D'Alessandro presented the 2024 SUSCD Board of Supervisors meeting dates for discussion. A motion was made by Ed Dec to approve the dates as presented. The motion was seconded by Jim Laine and unanimously passed. The meeting dates will be advertised in the newspaper and on the district website.

<u>Mailbox</u>-Matthew D'Alessandro presented a few quotes for a mailbox outside the front door. The Board discussed the options presented and instructed Matthew to research a few more quotes to be presented at a future meeting.

<u>Annual Budget</u>-Matthew D'Alessandro reported that he needed to adjust the breakdown of the insurance policies, but the overall total remained the same. The budget was conditionally approved at a previous meeting.
