2023 Grant. 2023 LAP re-grantee final reports are due on January 12th, 2024. Staff are reviewing reports as they are received and will release final payments once all necessary elements are met.

elements are met. Staff are also working on the final report to the New Jersey State Historical Commission which is due January 30th.

2024 Grant. On December 12th, 2023, the Somerset County Board of County Commissioners passed a resolution authorizing the following seven 2024 CHPP awards, totaling \$63,750:

All re-grantees have been notified of their grant awards. Staff is currently preparing all contracts for the 2024 grants. Organizations that did not receive funding have been notified as well. Staff is working on the 2024 contract to be submitted to the state. Staff have also been working with consultant ION Contracts and expect to pilot a digital contract submission process with a small selection of regrant organizations.

Cooperative Marketing Grant. The Cooperative Marketing Grant are funds the Commission receives from the NJ Division of Travel and Tourism to market and promote the Commission's Heritage Tourism event, Journey Through the Past.

2023 Grant. Staff is working on the final report due to the Division of Travel and Tourism in early February.

2024 Grant. Our 2024 grant was approved in the amount of \$12,450. The contract was finalized and submitted in late 2023. Staff has reached out to all the proposed vendors and will be confirming the ads once purchase orders have been generated.

Gallery. The Scrubs Paper Project exhibit opened on December 1st and features 65 pieces. The artwork, from Frontline Arts, was created on paper which is handmade from deconstructing donated scrubs and other medical garments. The project began in response to the COVID-19 pandemic as an opportunity for healthcare workers to tell their stories. Portions of the exhibit had been available online, but this is the first time the exhibit is displaying in person. On January 19th we will be opening two exhibits. The first is the Witness Stone Project form the Stoutsburg Sourland African American Museum. The second will highlight local artist Veronica Spruill.

Historic Preservation and History Awards. Nominations will open for the 2024 Historic Preservation and History Awards later this month and will be due by March 15th, 2024. Awardees will be notified in April, and a ceremony will be held in May. This year, nominations can be submitted online or through the traditional paper method. The following reports were made by Katie Himics:

National Endowment for the Arts (NEA) American Rescue Plan (ARP) Sub-granting for Local Arts Agencies Grant. Funds from the National Endowment for the Arts are intended to help support jobs in the arts sector, keep the doors open to arts organizations, and assist the field in its response to and recovery from the COVID-19 pandemic. Final reports were sent to the six regrant organizations in late November and were due January 10th, 2024. Staff are in the process of reviewing these final reports. Once all final payments have been made, staff will begin the close out process for these grants and submit our final reporting to the NEA.

New Jersey Historical Commission Project Grant. The Cultural & Heritage Commission has been awarded \$18,500 through the New Jersey Historical Commission Project Grant to fund the design and development of a Docent Training Program. This is the first year that Cultural & Heritage has been awarded the New Jersey Historical Commission Project Grant. A formal Request for Proposals (RFP) for consulting services was released on Monday, October 2nd, and closed on November 9th, 2023. An evaluation committee was formed to review all proposals submitted. In late December, an award of contract was made to Ahali Consulting LLC. Ahali Consulting LLC is a small, certified minority womenowned consulting firm headquartered in Jersey City. Ahali brings together the expertise and experience of industry professionals with human-centered design practices to cultivate innovative community solutions. In early 2024, staff will be meeting with the consulting team to begin project activities.

Teen Arts Festival. The Somerset County 2024 Teen Arts Festival will be held on Thursday, May 16th, at Raritan Valley Community College. This is the Commission's annual arts education opportunity for middle school and high school students throughout the County to come together and celebrate their accomplishments in the arts. Program Coordinator, Katie Himics, has taken lead in coordinating this year's festival. Our annual School Participation Forms were made available to schools in early October, and they were due back December 15th. We currently have 12 schools with approximately 900 students expected to participate this year. Staff are now beginning to acquire a roster of talented, respected, and diverse artists in the various creative disciplines to offer workshops and masterclasses for our students, as well as critique student work and performances.

The following reports were made by Tom Boccino:

Historic Preservation Grant Program. The Historic Preservation Grant Program is part of the Somerset County Open Space, Farmland and Historic Preservation Trust Fund.

2023 Grant. County Counsel is currently reviewing the grant contracts for the 4 projects that were awarded a total of \$931,821.00, and they will be sent out to the recipients once approved. Staff is beginning to work on getting the 2024 grant round moving and is currently reviewing the guidelines and application form for possible edits and updates.

County Historic Preservation Projects:

Van Horne House.

There is no update to report for the Van Horne House restoration. The County is still on track to begin the final phase of restoration this Spring.

County Court House, Façade Restoration Project.

The Courthouse Façade restoration project has been put on hold until next year. The consultants have inspected the building and had minor repairs made where necessary, so the building is structurally sound.

First Dutch Reformed Church, Stained Glass Window Project.

The Somerset County Engineering Department has gone out to bid for a maintenance contract, and once awarded the new contractor can begin work on the First Dutch Reformed Church stained glass repair project.

County Owned Historic Sites Assessment.

The consultant is finalizing the Historic Sites Assessment report which should be received by the County by the end of January. The case studies from neighboring County facility visits are also being finalized and will be a companion document to the full report.

The Old Stone Arch Bridge.

The closing for the Old Stone Arch Bridge property is scheduled for March 15th, 2024, and is still on track for that closing date. Middlesex County is contributing toward the purchase of the property and will be involved with Somerset County on the planning, archaeology, and development of the property. Somerset County staff has been working with the State Historic Preservation Office (SHPO) to address its inquiry into the purchase of the property and SHPO's involvement in the purchase. Information has been sent to SHPO for its review, and the County should be receiving a sign-off shortly.
