AN ORDINANCE ESTABLISHING A LEFT TURN LANE RESERVATION ALONG BONNIE BURN ROAD, COUNTY ROUTE 695, WATCHUNG BOROUGH SOMERSET COUNTY, NEW JERSEY

BE IT ORDAINED by the Board of County Commissioners of the County of Somerset, state of New Jersey that;

SECTION I. The location described is designated as a Left Turn Lane Reservation and traffic shall move as indicated.

<u>Intersection</u> <u>Movement</u>

Bonnie Burn Road Northbound left lane of County Route 695 and Bonnie Burn Road reserved Prospect Avenue for left turn only.

Bonnie Burn Road County Route 695

Bonnie Burn Road Northbound left lane of County Route 695 and Bonnie Burn Road reserved Johnston Drive for left turn only.

SECTION II. Regulatory signs, conforming to the current Manual on Uniform Traffic Control Devices for Streets and Highways, shall be erected and maintained to effect the above-designated lane reservations.

SECTION III. This ordinance shall take effect upon final passage and publication as required by law and upon approval by the Somerset County Engineer.

BE IT FURTHER ORDAINED that all previous ordinances or resolutions establishing turn reservations on the aforementioned roadway(s) or portions of the roadway(s) herein described are hereby repealed.
