



 - Local Environmental and Transportation
 - Hospitals
 - Local Media
 - Community Groups
 - Facility Representatives
 - Local Businesses

County Regions Jonathan Durland Emergency Response Manager Somerset County is very diverse, it is more manageable to have four regions within the county. These regions have similar numbers of EPCRA facilities. Please see the map below of the regions.



Regions are:

- Northern (102 CRTK Facilities / 12 EPCRA Facilities)
 - Bedminster, Bernards, Bernardsville, Far Hills, Green Brook, North Plainfield, Peapack Gladstone, Warren, Watchung
- Central (96 CRTK Facilities / 17 EPCRA Facilities)
 - o Bridgewater, Raritan, Somerville
- South West (103 CRTK Facilities / 19 EPCRA Facilities)
 - o Branchburg, Hillsborough, Manville, Millstone, Montgomery, Rocky Hill
- South East (99 CRTK Facilities / 20 EPCRA Facilities)
 - o Bound Brook, Franklin, South Bound Brook

Not all the municipalities currently have EPCRA facilities (those municipalities that are shaded out in the map above), they are still in a region because there is a potential for that to change in the future depending on what chemicals the facilities have. In addition, all numbers are subject to change and at each meeting we will provide an updated map and numbers.

EPCRA Facilities

There are 355 extremely hazardous substances that will deem a facility as an EPCRA facility.

	• Each facility that has been deemed an EPCRA facility due to the chemicals, must author an onsite emergency response plan that determines how they will respond to a situation occurring on site with those chemicals.

Procedures for information submissions & public request for ERP review:

- Facility On-site plans & chemical inventories shall still be submitted pursuant to EPCRA & NJDEP / NJDOH requirements (Local PD, FD, OEM, etc.) & via: LEPC@co.somerset.nj.us
 - Nothing changes for the facilities in the process of how they have always worked except for the addition of this email address on the email submittals.
 - A question came up from Paul Malarcher (Somerset County OEM and the RTK County Lead) regarding obtaining information that comes to the LEPC email address for his RTK work. Jonathan Durland and Paul Malarcher will work together to determine situations on a case-by-case basis.
 - · Facility on-site plans are not subject to public review
- Public request for ERP review:
 - Submit an OPRA request via Somerset County OPRA Portal: http://somersetcountynj.justfoia.com/publicportal/home/newrequest
 - Public Review must be conducted in a secure reading-room

LEPC Goals and Next Steps

- Finalize off-site ERP approval & provide to NJ SERC before 4/24/2024
- Collect information & update ERP document as needed
 - Review prior to August meeting
 - Develop template emails for public / facility information requests to the LEPC
 - There may be changes that occur since we will be receiving the updated RTK surveys before the next meeting, in addition the facilities get sorted by zip code and since many municipalities share the same zip codes at their borders, there are times facilities are classified as one municipality and it is incorrect.
- Develop agendas / identify topics for discussion and training within various Regions

Questions/Comments

Sidd Saran (Montgomery EMS) – the presentation is focused on chemical emergencies what about other emergencies?

• Durland –There is confusion between LEPC and Emergency Management Council (EMC). LEPC's are stipulated by EPCRA and the EPA. All other types of emergencies are addressed by your local Emergency Operations Plan (EOP) which is **not** OPRA-able. In the past, due to the confusion both plans were joined together which caused issues. This LEPC committee and plan creates a better division of these two plans. Some of the information may overlap but EPCRA and the EPA focus on the chemicals. This is why we are only focusing on chemical emergencies in this meeting and for this committee.

Martin Zelling (Franklin Township Resident) - what about railroad and trucking accidents the occur within the county?

• Durland - Since they are not fixed facilities, they are not subject to EPCRA.

James Edwards (Bridgewater OEM) – prior to the meeting looked into facilities but some facilities are classified as EPCRA but did not complete the RTK survey, who is responsible for enforcing they complete it?

	Durland – NJDEP is responsible for community right to know information and ECPRA falls into this. The County can contact the EPA to notify them of facilities that are not complying. The EPA will do their own investigation to see if they are compliant and there are mechanisms to fine them into compliance. Municipalities - if you are encountering this type of issue, please reach out to the County and we will try and help facilitate that communication with the EPA.					
	Martin Zelling (Franklin Township Resident) - how do you alert the public if something happens at a facility?					
	There are different mechanisms at	Durland – in the ERP there are objectives on the best ways to go about that. There are different mechanisms at the local, county and state level and we will continue to work on those notifications' avenues.
