<u>2024 Meeting Schedule</u>-Matthew D'Alessandro reported to the Board that the 2024 meeting schedule was posted on the website and in the local newspaper as required.

<u>District Action on Ch. 251-</u> The SUSCD Board reviewed the certified and completed projects for the dates from 12/13/23 to 1/23/24. Ed Dec recused himself from SUSCD File#2023-6289 from the certified list. Matthew Loper recused himself from SUSCD File#2021-4951 from the completed list. Matthew Loper made a motion to approve the plans on the certified and completed list for the period of 12/13/23 to 1/23/24. The motion was seconded by Jim Laine and unanimously passed.

Annual Reorganization Meeting-Matthew D'Alessandro opened the floor for nomination of the Chairman position as part of the annual reorganization meeting. A nomination for Mark Kirby as the SUSCD Chairman was made by Matthew Loper. The motion was seconded by Ed Dec and unanimously passed. A motion was made by Matthew Loper to close the nomination for Chairman. The motion was seconded by Bob Amberg and unanimously passed. Mark Kirby, Chairman then opened the floor for nomination of Vice Chairman. Matthew Loper nominated Jim Laine as Vice Chairman. The motion was seconded by Ed Dec and unanimously passed. A motion was made by Bob Amberg to close nominations for the Vice Chairman position. The motion was seconded by Ed Dec and unanimously passed.

<u>Mailbox (outside front door)</u>-Matthew D'Alessandro stated that he would like to submit a 4H Building and Grounds application for the installation and use of a mailbox outside the front door for packages and mail outside business hours. Matthew reported that he would like to seek approval before purchasing a mailbox. Matthew will submit the application and will report back to the SUSCD Board.

NJBOA Presentation-Matthew D'Alessandro reported that he was asked to do a presentation to the NJ Building Officials Association about the relationship between soil conservation districts and the townships, specifically the building departments. He will be doing the presentation on 2/28/24 in Scotch Plains, NJ.

He cited his recent accomplishments, experience, endeavors with both counties and being the newly anointed President of the NJ Employees Association for the program. Upon returning to the meeting, the SUSCD Board stated they would need to table the discussion and would like to form a subcommittee to research the request further and would get back to Matthew D'Alessandro.</u>
