- NJDCF has launched a new webpage for our "Family Connects NJ" (home visiting program for parents of newborns). The website is here: Family Connects NJ Note that this is initially starting in five counties: Essex, Middlesex, Mercer, Gloucester and Cumberland. (For the counties that are not yet active, there is still a link that will get the parent to the "Connecting NJ Hub", which does provide resources for all counties.) On the Family Connects NJ webpage, in addition to the links at the top of the page, there are five informational topics in the *scrolling banner*. These are: "Birth Families" (the benefits of participating in the program, including a Q&A and Fact Sheet), "Adoptive Parents and Resource Families" (the programmatic benefits for these parents, including a Q&A), "Bereaved Families" (Stillborn or recent death of newborn I including a Q&A), "Doctors/Clinicians" (includes a fact sheet for medical practitioners and a Q&A), "Registered Nurses" (includes a fact sheet and a Q&A). NOTE: Somerset County will be eligible in January 2025.
- NJDCF will be exhibiting at the "NJ Recreation and Parks Association Conference" at Harrah's Waterfront Conference Center, Atlantic City from February 25th to 28th, 2024. V. Human Services Director's Report – Mike Frost

• Budget submission was finalized including recommendations for Non-Profit Purchase of Service (NPPOS). A recommendation was made to the commissioners for a hefty increase. The typical increase is 2%. Expecting the budget to come in earlier this year hopefully around April.

- Expanded Community Police Alliance program. Victor Flores-Lopez is the coordinator in Bound Brook. Hoping to expand into two more municipalities within this budget cycle.
- Under Lisa Federico's direction the county has been providing staff Narcan training. A policy has passed so Naloxone will be available in AED boxes.
- Meg Isbitski has continued to work on a clinical resource directory and CIT training.
- Zachary Berliner has been on family leave since December 2023. Is expected to return February 5, 2024.
- Meg Isbitski, Mental Health Administrator will be resigning February 20, 2024, and will become a clinician in the cares program at Richard Hall Community Health and Wellness Center.
- Mike Frost shared he is retiring July 1, 2024. The Director of Human Services position has been posted.

VI. Committee Reports

Executive Committee- Rheanah Johnson

• The committee met on January 8, 2024. The committee will focus on youth and mental health services, particularly with a focus on immigrant families. The initial steps will be to connect with local partner agencies that work with these populations to gain insight into barriers and trends. Rheanah met with Melinda McCabe of the Child Advocacy Center. The committee will be meeting with an organization known as Church World Service about their organization and about their work with unaccompanied minors across the state of New Jersey. The program manager for Refugee Health Promotion leading their mental health initiatives will be on the call as well. The meeting is scheduled for February 5, 2024. The committee is also working to meet with the McKinney-Vento Education for Homeless Children & Youth Program.
