III. Presentation from the Community Police Alliance by Dameon M. Stackhouse, LSW

- Mission Statement
 - O The Community Police Alliance Coordinator's (CPAC) mission is to bridge the gap between the Community and Law Enforcement and respond to Mental Health crises, substance use, domestic violence services, housing and food, childcare, healthcare, and other resident issues with Bridgewater Police Department (BPD) and Bound Brook Police Department (BBPD). The CPAC's focus is on reducing harm to the public, saving law enforcement resources, and creating a better community for everyone. The Community Police Alliance is here to ADVOCATE for our residents and ensure that they receive all resources available!
- What Does a CPAC do?
 - The Community Police Alliance Coordinator (CPAC) will receive, analyze, act upon, and followup on referrals provided to the coordinator by participating law enforcement agencies.
 - Provides information and referral, as well as linkages to community services, such as mental health and substance use, domestic violence services, housing and food, childcare, healthcare, etc.
 - Provides psychoeducation, linkage, and ongoing support to individuals and families in the community who have been identified by local law enforcement, whether because they appear to have acute unmet needs, or have a pattern of behaviors requiring law enforcement intervention.

- Mike's last day in the office is June 6th and the last meeting will be next month.
- Zachary Berliner has been named as the new Director of Human Services and will start June 1st.
- The Mental Health Administrator position is still vacant.
- The formal budget presentation for the County was held on April 23, 2024, and the formal acceptance will be May 28, 2024. The Department asked for an 8% increase from the last bottom line amount for the Non-Profit Purchase of Service and was approved. Formal allocations cannot be shared until the budget officially passes.

VIII. Agency Highlights/Announcements

- Paul Grzella-
 - The Greater Raritan Workforce Development Board (GRWDB) is hosting a Youth Apprenticeship Career event at Raritan Valley Community College (RVCC) on May 6, 2024 from 5:30 pm 7: 30 pm. It is open to the public and there will be about 32 business present and food will be provided.
 - o Greater Raritan Annual Job Fair Registration is now open for employers. It is open to all types of businesses. Typically, there at 70-80 employers and usually 300-400 job seekers. The link for job seekers will be open next week.

o May 3rd is the deadline for registration GRWDB received their Summer Youth Work Experience Program grant which allows for 90 youth to work. Criteria includes ages 16-24 in or out of school. The youth will be paid \$16 an hour for 200 hours. 180 hours are on site and 20 hours will be online work experience. The payment is a stipend and is tax free.
