### AGREEMENT FOR ISSUANCE OF A CONDITIONAL REPORT OF COMPLIANCE

Whereas, the New Jersey Soil Erosion and Sediment Control Act, Chapter 251, P.L. 1975 prohibits the issuance of a certificate of occupancy by a municipality until there has been compliance with the provisions of a certified plan for permanent measures to control soil erosion and sedimentation,

Whereas, the Somerset-Union Soil Conservation District, hereinafter called "District," and the Applicant have agreed that there are sound planning, environmental or practical reasons for delaying certain actions which must be completed pursuant to the approved soil erosion and sediment control plan for:

Whereas, the District has estimated the cost of completing the applicant's compliance with the approved plan and the applicant has agreed to post a cash deposit to guarantee performance of the remaining provisions of the approved plan in consideration for the District's issuance of a report of compliance.

2. This District agrees to promptly deposit such monies in an interest bearing account at the Somerset Savings Bank and to retain such funds as a guarantee of completion of all work shown on the approved plan for soil erosion and sedimentation.
3. The applicant agrees to complete all such unfinished work as soon as conditions allow and in no event shall such work remain unfinished after \_\_\_\_\_.
4. In the event the applicant delays the completion of such work beyond the date set forth in paragraph 3, the district shall have the right in its sole and absolute discretion to expend all monies paid by the applicant pursuant to this agreement to accomplish, or attempt to accomplish the completion of the required work. In the event such monies are not sufficient to complete the necessary work, the applicant agrees to provide sufficient additional funds to do so.
5. In the event the work shall be completed by the applicant or in the event it shall be completed by the District and there shall be funds remaining in the account established under the terms of this agreement, the District shall return to the applicant the performance deposit, plus interest accrued, minus District administrative fees.
