# What is Domestic Violence?

**Domestic Violence** is a pattern of behaviors used by one partner to maintain **power** and **control** over another partner in an intimate relationship.

**Domestic Violence** affects people of all genders, sexualities, races, religions, and income brackets, including 1 in 3 women and 1 in 4 men.

**Domestic Violence** is not just physical; these behaviors can be emotional, financial, sexual, digital, coercion, and other tactics utilized over time. The abuser slowly isolates their partner to increase reliance on him or her.

This can look like:

- Degrading and shaming, especially in public
- Extreme jealousy
- Accusations of infidelity without basis
- Controlling financial decisions
- Blaming for the abuser's behavior
- Coerced and forced sexual interactions
- Pressure to use alcohol and drugs
- Threats of intimidation and retaliation

Those experiencing domestic violence may stay in the relationship due to fear, belief that the abuse is normal or deserved, embarrassment or shame, love for their partner, cultural or religious reasons, language barriers or immigration status, lack of money or resources.

This guide outlines resources related to mental health, safety planning, housing, legal, and advocacy to educate, empower, and reduce the power that domestic violence has on our residents.



## Domestic Violence Resources Safe+Sound Somerset

Safe+Sound Somerset is the domestic violence agency serving Somerset County residents. They offer 24-hour access to a confidential, safe house for adult and child victims of domestic violence. A separate safe house location for male victims of domestic violence is available.

Contact the 24-hour Call/Text Hotline for shelter services screening at (866) 685-1122. In case of emergency contact 911.

The following programs are also offered by Safe+Sound Somerset:

- Individual and Group Counseling for Adults.
- Supportive Listening Groups.
- Youth Programs to Support Healing and to End the Cycle of Violence.
- Family Therapy with the non-offending parent.
- Transitional Housing program for persons leaving emergency housing services
- Accompaniment at Police Stations by Domestic Violence Response Team (DVRT) Volunteers to provide support and information when incidents occur.
- Sexual Assault Response Team: 24-hour responding service providing an advocate to a police station or Robert Wood Johnson Somerset to provide support following an assault.
- Legal Advocacy program provides safety planning assistance, accompaniment to court, advocacy with law enforcement, court personnel and legal services, information about domestic violence law, legal clinics and pro bono individual consultations conducted by volunteer attorneys, and referrals to further law services if applicable.
- Community Education: professional trainings, public presentations, and education for youth.
