WHEREAS, in accordance with N.J.S.A. 40:33A-1 et. seq. the Somerset County Board of County Commissioners adopted a resolution creating the Somerset County Cultural & Heritage Commission on August 2, 1983; and,

WHEREAS, by resolution adopted on April 7, 1987, by the Board of County Commissioners, the Somerset County Cultural & Heritage Commission was designated as the official County Arts Agency for the administration of the New Jersey State Council on the Arts Block Grant Funds (now New Jersey State Council on the Arts Local Arts Program Grant); and,

WHEREAS, the County of Somerset is the owner of real property known as Lot 4 in Block 350, 941 East Main Street in the Township of Bridgewater consisting of approximately 1.9 +/- acres, herein after referred to as the "Van Horne House"; and,

WHEREAS, the Van Horne House was constructed in 1754 by Phillip Van Horne, who was known to entertain both American and British guests, and became the headquarters of American Generals Benjamin Lincoln and William Alexander (Lord Stirling) until the April 1777 Battle of Bound Brook; and,

WHEREAS, the Van Horne House is listed on the State and National Register of Historic Places; and,

WHEREAS, the Heritage Trail Association has indicated that it is desirous in renewing its current lease of the Van Horne House for the purpose of hosting public events and providing educational programming to support the mission of the Association; and,

WHEREAS, the County and Heritage Trail Association have agreed to renew the lease for a period of five (5) years from the date of execution of an agreement; and,

NOW, THEREFORE, BE IT RESOLVED that the Commissioner Director, Administrator, and the Clerk are hereby authorized to execute a Lease Agreement with the heritage Trail Association approved as to form and content by County Counsel, a copy of which is on file with the Clerk of the Board.

WHEREAS, the Borough and Township have indicated that they are desirous in renewing their 1998 lease of Van Horne Park for the purpose of using it as a park and recreational area for the borough and Township and their residents, as well as other residents of the County and the State of New Jersey; and,

WHEREAS, the County, Township and Borough have agreed to renew the lease for a period of twenty-five (25) years from the date of execution of an agreement.
